The Sheriff took charge of the jury and recorded six exhibits. Twenty five witnesses were duly sworn and testified.

PRESIDING CORONER'S COMMENTS:

The following is a brief summary of the circumstances of the death as set out in the evidence presented to the jury at the inquest. The following summary of the evidence as presented at the inquest is to assist the reader to more fully understand the Verdict and Recommendations of the jury. This summary is not intended to be considered evidence nor is it intended in any way to replace the jury's verdict.

The jury heard evidence that on the evening of August 13, 2007, members of the Vancouver Police Department were called to a disturbance at a restaurant near Granville Street and West 12th Avenue. It is understood that Paul Boyd, a 39 year-old man suffering from Bipolar Disorder and associated paranoia, had entered the restaurant and alarmed those present by shouting at customers and staff. Prior to the arrival of police, Mr. Boyd left the restaurant and walked southbound on Granville Street. He was followed by a witness who called 911 and relayed Mr. Boyd's position to the call taker.

Minutes later, Mr. Boyd approached a man seated on a bench on Granville Street, near 16th Avenue. Mr. Boyd began yelling nonsensically at this individual, thereby coming to the attention of many passersby and residents of a nearby apartment building.

Two police officers arrived and encountered Mr. Boyd, who approached their police car in a non-aggressive manner, but was seen to have a hammer in his hand. Once he saw the hammer, one of the officers drew his firearm, pointed it at Mr. Boyd and demanded that he drop the hammer and lay on the ground. Mr. Boyd immediately complied. As a second officer approached Mr. Boyd to handcuff him, Mr. Boyd immediately leapt to his feet, produced a bicycle chain with a lock attached and swung it at the officer, striking the officer's head.

A second police vehicle carrying two other officers arrived at or about this time, one of whom immediately attempted to use empty handed strikes and blows with his police baton in order to gain control of Mr. Boyd, to no avail. Mr. Boyd also struck this officer with the chain.

The other officer who had arrived in the second vehicle drew his firearm and over the next 81 seconds, fired nine times, striking Mr. Boyd eight times. Four other officers arrived at various stages during the 81 seconds. Of the eight officers involved in this incident in total, only one discharged his weapon.

The jury heard evidence that Mr. Boyd was crawling toward the officer when he sustained the fatal gunshot wound, including the expert evidence of a forensic pathologist who testified that the bullet trajectory was consistent with Mr. Boyd's upper body being parallel to the ground when the bullet struck him. The forensic pathologist also testified that of the eight bullets that struck Mr. Boyd, this was the only one sufficient to cause immediate death.

JURY RECOMMENDATIONS:

1. We recommend mandatory utilization of extended leave, as defined in the Mental Health Act, for a person(s) suffering from a serious mental illness to ensure the person's well-being, mental health, and safety of the public.
2. We recommend funding by the Ministry of Health to provide additional dedicated teams such as "CAR 87" for mental health emergencies on a 24 hour basis.
3. We recommend the establishment of 24-hour community based walk-in clinics for the mentally ill.

Presiding Coroner's Comment: The jury heard evidence that Mr. Boyd may have benefitted from increased medical supervision and more readily available access to medical care in the community.

4. We recommend a review of E-Comm's internal communication structure and co-ordination of incoming calls.
5. We recommend that E-Comm implement a more effective means of coordinating information between E-Comm and Emergency Services.

Presiding Coroner's Comment: The jury heard several 911 recordings related to this incident. The jury also heard evidence that information provided by a 911 caller is relayed through numerous persons before it is provided to police officers and other first responders.

- 6. We recommend the establishment of a joint databank between the mental health department and the Vancouver Police Department of people with mental health issues.

Presiding Coroner's Comment: *The jury heard evidence that police officers often encounter individuals with known mental health issues and that this information may not be available to the officers at the first response level.*

- 7. We recommend a review of all significant police incidents for assessing the effectiveness of police training.
- 8. We recommend increased mandatory training for police officers interacting with persons suffering from mental health issues with emphasis on effective de-escalation tactics.
- 9. We recommend intermediate weapons made available to all VPD officers

Presiding Coroner's Comment: *The jury heard evidence that VPD patrol officers regularly encounter individuals with mental health issues while in the performance of their duties.*

The jury also heard expert evidence in the area of use of force by police personnel and the need for police officers to assess a threatening situation on an ongoing basis and de-escalate the level of force used as the threat against themselves or others is reduced.

The jury heard evidence that not all VPD officers are trained in the use of and/or provided with intermediate weapons such as Tasers and "beanbag" shotguns.
