

**SCHEDULE KK –  
TELUS PRIOR AGREEMENTS AND RELATED SPECIAL TERMS**

**1. Introduction**

This Schedule sets out (a) the TELUS Prior Agreements by GPS Entity, along with any special terms and conditions applicable thereto and (b) the processes for adding or correcting TELUS Prior Agreements if, and to the extent, certain errors or omissions have occurred in respect thereof.

In addition to the above, the MCSA shall be a TELUS Prior Agreement for each GPS Entity.

### 3. Subsequently Identified Agreements

- 3.1 If within twelve (12) months after the Effective Date a party identifies any other agreement between a GPS Entity and a member of the TELUS Group for the provision of telecommunication or related services which are generally within the scope of the Available Services that was not identified as a “TELUS Prior Agreement” in this Schedule as of the Effective Date (a “**Subsequently Identified Agreement**”), then such party may refer the matter to the Governance Process for determination of whether the Subsequently Identified Agreement should be a TELUS Prior Agreement for the purposes of this Agreement.
- 3.2 If in accordance with the Governance Process it is determined that a Subsequently Identified Agreement is to be a TELUS Prior Agreement, then without affecting any right or obligation of a party under the Subsequently Identified Agreement arising prior to the Effective Date, such Subsequently Identified Agreement, will be terminated and except as the parties may otherwise agree, replaced by this Agreement effective the Effective Date, with retroactive effect thereto, and the following terms will apply:
- 3.2.1 from and after the Effective Date the Subsequently Identified Agreement will be deemed to be an TELUS Prior Agreement and, if applicable, the respective Service Tower Commitment (including Service Orders and Service Change Orders comprising such Service Tower Commitment) for the GPS Entity will be amended accordingly through the Change Process including in respect of the services set out in the Subsequently Identified Agreement;
- 3.2.2 the record of Services maintained by TELUS pursuant to section 7.4.6 will be updated to include all relevant information from the Subsequently Identified Agreement; and
- 3.2.3 as of the Effective Date, TELUS hereby releases such GPS Entity from any termination fees or other amounts that would otherwise be payable by any GPS Entity to TELUS with respect to the termination of the Subsequently Identified Agreement pursuant to this section 3.
- 3.3 If the parties disagree as to whether a Subsequently Identified Agreement should be a TELUS Prior Agreement for the purposes of this Agreement, the parties will jointly consider through the Governance Process the following factors:
- 3.3.1 whether fees payable in respect of the Subsequently Identified Agreement were included in the calculation of the initial Revenue Commitment; and
- 3.3.2 whether the services provided under the Subsequently Identified Agreement are within the scope of the Available Services,

which if answered in the affirmative will favour inclusion of the Subsequently Identified Agreement as a TELUS Prior Agreement.

#### **4. Improperly Described Agreements**

- 4.1 If within twelve (12) months after the Effective Date a party identifies an error or omission in the description of any TELUS Prior Agreement, including the special terms and conditions applicable thereto, in an Exhibit to this Schedule, then such party may refer the matter to the Governance Process for determination of whether the Exhibit should be corrected and, if in accordance with the Governance Process it is determined that the Exhibit is to be corrected, then the parties will correct the Exhibit accordingly through the Change Process.
