**SUPERVISORY REVIEW OF PROPOSED AMENDMENTS TO THE FEDERAL-
PROVINCIAL AGREEMENT FOR CHICKEN – SCHEDULE “B” OPERATING
AGREEMENT**

RESPONSE TO NEW INFORMATION REQUESTED

The BC Farm Industry Review Board (BCFIRB) has become aware of new information, as outlined in this extract from the April 14, 2016 minutes of the BC Chicken Marketing Board, which the panel believes should be disclosed as it potentially relates to the proposed Operating Agreement amendments that are under BCFIRB consideration:

3.8 Ontario Kosher Chicken:

The Chair brought up the topic. It was discussed with a view to seeing if (sic) Ontario was amendable to cancelling its discrete supply in favor of support for the addition of kosher chicken to the CFC specialty program. The Chair and ED of BC to set up a meeting with the Chair and ED of CFO to discuss the issue. It would give CFO their required 7000,000 kg/cycle under specialty and take away 200,000 kg/cycle under the discrete supply over the 10 year period of the MOU from the mainstream allocation.


