The **Security Services Act (SSA)** and **Regulation (SSR)** came into force on **September 1, 2008** replacing the **Private Investigators and Security Agencies Act (PISA)**. The **Body Armour Control Act (BACA)** and **Regulation (BACR)** came into force on **July 1, 2010**. Violation tickets issued where payment has not been made remain in effect.

Violation tickets are entered on this page when:

- a violation ticket is not disputed within 30 days of being served the business entity is therefore deemed guilty as stated in Section 14 of the [Offence Act](http://www.bclaws.ca) – [www.bclaws.ca](http://www.bclaws.ca)
- or
- the business entity attended court and was found guilty.

Violation ticket penalty information will remain on this page for a period of one year from the date posted and will be removed after one year providing the violation ticket is paid.
