



## Violation Tickets issued under the *Security Services Act* or Regulation *Body Armour Control Act* or Regulation

The *Security Services Act* (SSA) and Regulation (SSR) came into force on September 1, 2008 replacing the *Private Investigators and Security Agencies Act* (PISA). The *Body Armour Control Act* (BACA) and Regulation (BACR) came into force on July 1, 2010. Violation tickets issued where payment has not been made remain in effect.

Violation tickets are entered on this page when:

- a violation ticket is not disputed within 30 days of being served the business entity is therefore deemed guilty as stated in Section 14 of the [Offence Act](http://www.bclaws.ca) – [www.bclaws.ca](http://www.bclaws.ca)
- or
- the business entity attended court and was found guilty.

Violation ticket penalty information will remain on this page for a period of one year from the date posted and will be removed after one year providing the violation ticket is paid.
