

Entry of 2015 Seedling Requests in SPAR (Seed Planning and Registry system)

Request Entry and Approval Deadlines

1. Deadline for entry and approval of 2015 ministry-funded and administered seedling requests for all species from South or West Coast region TSO's or districts i.e. TCH, TSG, TST:
Friday, August 15, 2014.

2. Deadline for entry and approval of 2015 ministry-funded and administered seedling requests for **'early sow' species and stocktypes is Tuesday, September 16, 2014.** Seedlings which fall in the 'early sow' category include the following:

'Early Sow' Stock Types

- 1 + 0 - Yellow Cedar (Yc) seedlings or cuttings
- 1 + 0 - White Pine (Pw)
- 1 + 0 - Amabilis Fir (Ba)
- 1 + 0 - Subalpine fir (Bl)
- 1 + 0 - Noble fir (Bn)
- All species and stocktypes for planting in 2015 summer or 2015 fall
All species and stocktypes for transplanting in 2015 summer (half year transplants)

2. Deadline for entry and approval of 2015 ministry-funded and administered seedling requests for **all other species and stocktypes is Wednesday, October 15, 2014.**

Funding Source codes

Funding source codes in SPAR for 2015 seedling requests are shown in the following table. Funding source will partially determine availability of reserved seed. Reserved seed owned by BC Timber Sales (BCTS 00) will be available only to BCT funded requests. Reserved seed owned by MOF 01 will be available to all other Ministry funded requests. Reserved seed owned by MOF 27 (south) and MOF 28 (north) will be available only to FTM funded requests. Please ensure seedling requests order seed with the appropriate ownership, when available.

Entry of Seedling Requests in SPAR

Entry of Ministry-Funded Seedling Requests for BC Timber Sales

BC Timber Sales seedling requests should be entered with **Funding Source** of **BCT**. The Seedling Request Org Unit should be entered as the District Org Unit of the planting location eg. **DKA** (Kamloops Forest District). The Request **Agency** should be entered as the acronym for the Timber Sales office and local field team eg. **TKA 02** (Kamloops TSO; 100 Mile House Field Team). This will facilitate seedling shipping and storage when needed. Please see BC Timber Sales Client location codes table.

The Nursery Contract Review Board (NCRB) has recommended that a process be established to allow field teams to combine summer and fall plant seedling requests for various species and stocktypes to ensure the seedlings produced will come from a single nursery. The main reason for this process is to facilitate coordinated delivery of the hot-lift seedlings to allow for mixed species planting.

The key to ensuring that seedling requests are assigned to one nursery is to ensure that they are combined in only one bid group which is subsequently assigned to one nursery in the tendering process. BCTS HQ staff need to be made aware at the time of seedling ordering of any groups of seedling requests that the operational TSO staff want combined.

The process to ensure your seedling requests are combined is as follows:

- Create new seedling requests in SPAR
- Determine which requests will be combined depending on planting stock amounts and allocation, mixed species blocks, remote camps, other unique factors
- Prior to setting the request key status to approved, indicate in the SPAR Additional Criteria / Comment field of each request key the other request keys which will be combined (eg. this request key is to be combined with 2015DPC0005 and 2015DPC0006 for the purpose of tendering in one bid group)
- Send email notification to Patti Kagawa with request key details so combining requests can be done at the time of seedling tender and bid group preparation.

BCTS Seedling Services staff reserve the right to limit the numbers and types of seedlings in any one bid group. The maximum number of seedlings in any one bid group is one million seedlings for summer plant. For spring planting, seedling request size should be limited to a maximum of 400K for risk management reasons.

Entry of Ministry-Funded Seedling Requests for Forests For Tomorrow

Ministry-Funded Seedling Requests including those for ITSLs should be entered with Funding Source of **FTM** (Forests for Tomorrow). The Seedling Request Org Unit should be entered as the District Org Unit of the planting location eg. **DRM**. The Request Agency should be entered as the client acronym for the Ministry of Forests, Lands and Natural Resource Operations (**MOF**). Client Location codes have been added for each Forest District for FFT funded seedling requests. Use these location codes for 2015 eg MOF 33 for FFT-DRM.

Entry of Ministry-Funded Seedling Requests for the Forest Stand Management Program

Seedling Requests funded by the Forest Stand Management Fund should be entered with Funding Source of **GFS**. The Seedling Request Org Unit should be entered as the District Org Unit of the planting location eg. **DKA**. The Request Agency should be entered as the acronym for the District Org Unit eg. **DKA 00**.

Entry of Seedling Requests funded with Section 108 claim

Seedling Requests funded by the Forest and Range Practices Act Section 108 should be entered with Funding Source **BCT**. The Seedling Request Org Unit should be entered as the District Org Unit of the planting location eg. **DKA**. The Request Agency should be entered as the BCTS acronym i.e. **TKA 01**.

Indicate in the SPAR Additional Criteria / Comment field that this request key is to be funded by Section 108 funds, so the keys can be tracked.

Send email notification to Patti Kagawa with request key details so Section 108 request keys can be tracked and funded correctly.
