Highlights

The Quarterly Environmental Enforcement Summary for Q1 2013 outlines 3 Orders, 59 Administrative Sanctions, 320 Tickets, and 14 Court Convictions for a combined total of over \$160,000 in penalties.

Notable Highlights this Quarter:

A numbered company was convicted in court for a violation under the *Water Act*. **374917 BC Ltd** was fined \$1,150 and ordered to pay an additional \$54,000 in creative sentencing to the Habitat Conservation Trust Foundation for unlawfully diverting water from a stream. The company operates a cranberry farm on approximately 2,000 hectares near Pitt Meadows in the Lower Mainland.

In the second quarter of 2012, the ministry reported court convictions involving **Upper Stikine River Adventures** and owner **Gerald Geraci**. The guide outfitting operation and its owner had been convicted in court on over twenty charges and fined almost \$50,000 for illegal guiding activities. The Conservation Officer Service (COS) initiated the investigation into the operation after receiving a tip from a First Nations group. The investigation involved 18 COS staff and 2 US Fish and Wildlife Agents taking 23 statements from 13 different individuals, resulting in the seizure of 20 animals including stone sheep, mountain goats, caribou, moose, grizzly bear and wolf.

In connection with that investigation, **Upper Stikine River Adventures** guide outfitter **Wesley Allen Berge** was in court this quarter, pleading guilty to eight charges under the *Wildlife Act*, receiving a total of \$34,500 in fines. Through their licence, guide outfitters are representatives of the Crown in British Columbia. As such, they are held to a high standard of conduct and must always operate within the law. Guides must also be aware of and monitor the actions of their employees and clients to ensure that they are also operating within the law.

MacKenzie Pulp Mill Corporation received 5 violations tickets under the *Environmental Management Act* for introducing waste to the environment. The non-compliance is related to their permit requirements for boiler emissions and maintaining proper air quality standards. Ministry staff continue to work with the pulp and paper operation to bring them into compliance with their permit conditions.

For the second time since its introduction in 2009, the ministry put forward charges under the new Controlled Alien Species Regulation, resulting in a conviction and \$2,000 penalty (\$1,500 of that will be directed to the Habitat Conservation Trust Foundation). **Kristopher Benson** was found guilty of possessing a prohibited alien species without a permit. Benson was keeping a young black jaguar at his Rosedale property for use in the film industry. Conservation Officers transported the animal to the care of the Vancouver Zoo.

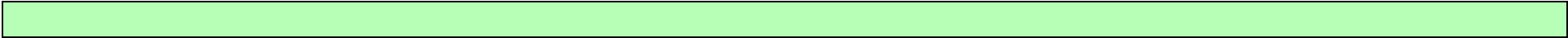
