Highlights

This quarter marks ten full years of publishing environmental enforcement results for British Columbians in the *Quarterly Environmental Enforcement Summary (QEES)*. To date over 23,000 enforcement actions, totalling almost \$9 million in environmental penalties have been published in the QEES and posted on the searchable Environmental Violations Database. The purpose of proactively disclosing this important information is to keep the public and our stakeholders apprised of government's environmental enforcement activities, while also providing an additional deterrence to businesses and individuals from breaking environmental laws.

British Columbia strives to keep its environmental enforcement reporting at the leading edge across Canada, expanding the scope of reporting as well as the format for viewing the content. While the QEES was launched in 2006, the Environmental Violations Database was introduced in 2011, providing a dynamic searchable database for the enforcement actions. The ministry also began reporting overdue environmental court penalties in 2013 as part of a concerted effort to increase the payment of these important fines, resulting in a payment increase from 40% to 91%. Three new enforcement actions have also been added to the reporting regime – Community Environmental Justice Forums and just added this quarter – Administrative Penalties and Orders to Remedy.

New Enforcement Actions:

Administrative Penalties have been added to the enforcement toolkit under the *Environmental Management Act* and the *Integrated Pest Management Act*. These financial penalties are imposed outside of the court process by designated ministry officials, offering a middle ground response to non-compliance, between relatively lower-range violation tickets and the more punitive court prosecution process. Administrative penalties are designed to level the playing field among regulated parties by removing any financial benefit, advantage or gain achieved by breaking the law. Administrative penalties provide flexibility when addressing a wide range of non-compliance scenarios, including:

- Contravention of a requirement of a regulation or Act;
- Failure to comply with an order issued by the ministry; or
- Failure to comply with the terms or conditions of a ministry issued authorization (permit or license).

Orders to Remedy are enforcement actions issued by the Environmental Assessment Office (EAO) to Environmental Assessment Certificate holders for failing to comply with the terms of the certificate. Including these enforcement actions in the *Quarterly Environmental Enforcement Summary* marks a step toward more coordinated reporting across the Natural Resource Sector.

Highlights

Highlights this quarter:

The Quarterly Environmental Enforcement Summary for Q4 2015 outlines 4 Orders, 78 Administrative Sanctions, 2 Administrative Penalties, 589 Tickets, and 24 Court Convictions for a combined total of over \$250,000 in penalties.

Nexen Energy pled guilty in provincial court to breaching regulations under the *Water Act*. The company was found to be out of compliance with the terms of its licence when drawing water from North Tsea Lake to supply a hydraulic fracturing operation in the north-eastern corner of the province. The company was ordered to pay a fine of \$1,000 and make a \$74,000 payment to the Habitat Conservation Trust Foundation.

Diamond Enterprises Ltd was issued a \$10,000 administrative penalty for failing to comply with a Site Investigation Order issued in relation to a suspected contaminated site in the Lower Mainland. The property is currently the site of a gas service station.

Maple Hill Farms of Abbotsford was also issued a \$5,000 administrative penalty for contravening a requirement under the Recycling Regulation as a producer of packaging and printed paper to have an approved stewardship plan in place or have a stewardship agent appointed to oversee the plan on their behalf.

Tulsequah Chief Mine (Chieftain Metals Corp) received an Order to Remedy after staff from the Ministries of Energy and Mines, Environment and the Environmental Assessment Office determined that the Environmental Assessment (EA) Certificate holder was in non-compliance with the spill prevention requirements of the EA Certificate.

Interior – Lower Mainland Transmission Project (BC Hydro and Power Corp) received an Order to Remedy for failing to adhere to requirements in their EA Certificate to prevent the spread of invasive plants.

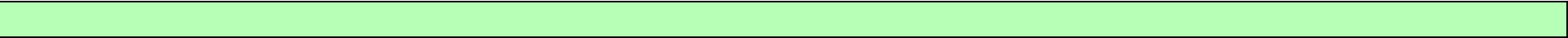
