The Administrator in Council:

Res. No 1578/60

The undersigned has the honour to recommend that pursuant to subsection (1) of section 16 of the "Placer-mining Act", chapter 214 of the Revised Statutes of British Columbia 1948, a reservation be placed upon all minerals in the following lands in the Lillooet Mining Division, Lillooet Land Recording District, namely:

That portion of Lot 3, Group 1, commencing at a point on the easterly boundary of said lot 1050 feet southeasterly from the northeast corner of said lot; thence west 760 feet more or less to the westerly boundary of said lot; thence southerly 1100 feet along the westerly boundary of said lot; thence east 490 feet more or less to the easterly boundary of said lot, being the right bank of the Fraser River; thence northerly along the easterly boundary of said lot to the point of commencement and

That portion of Lot 4704, commencing at the northwest corner of said lot; thence easterly 800 feet along the northerly boundary of said lot; thence southerly 300 feet parallel to the westerly boundary of said lot; thence westerly 800 feet parallel to the northerly boundary of said lot; thence northerly 300 feet along the westerly boundary of said lot to the point of commencement and

That portion of Lot 450, commencing at the southeast corner of said lot; thence northerly 1100 feet along the easterly boundary of said lot; thence west 2890 feet more or less to the easterly boundary of lot 325; thence southerly along the easterly boundary of Lot 325 to the southeast corner of said lot; thence westerly along the southerly boundary of Lot 325 to the southwest corner of said lot; thence southerly 368 feet more or less along the easterly boundary of Lot 145 to the southwest corner of Lot 450; thence easterly along the southerly boundary of Lot 450 to the point of commencement and

That portion of Lot 145, commencing at the southeast corner; thence northerly 1550 feet along the easterly boundary of said lot; thence westerly parallel to the south boundary of Lot 145 to the westerly boundary of said lot; thence southerly along the westerly boundary of lot 145 to the southwest corner of said lot; thence easterly along the southerly boundary of said lot to the point of commencement and
