The undersigned has the honour to recommend that pursuant to Sub-section 1 of Section 16 of the "Placer-mining Act", Chapter 214, Revised Statutes of British Columbia 1948, a reservation be placed upon all minerals in the following described lands in the Golden Mining Division, namely:
