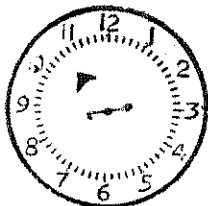

THAT pursuant to the Mineral and Placer-mining Acts and all other powers thereunto enabling, no person may locate or mine in or upon the following described lands in the Alberni Mining Division:

Commencing at the north east corner of Lot 196, Clayoquot District; thence easterly along the northerly boundary of Lot 167 to a point on the high water mark on the southerly shore of Tofino Inlet, west of Grice Bay; thence North 63° East to a point on the high water mark on the southerly shore of Tofino Inlet, north of Indian Bay; thence south easterly in a straight line to the most northerly north west corner of Lot 645; thence southerly in a straight line to the north east corner of Lot 1473; thence southerly along the easterly boundaries of Lots 1473 and 1472 to the south east corner of Lot 1472; thence southerly in a straight line to the north west corner of Lot 1418; thence southerly along the westerly boundaries of lots 1418 and 1419 to the south west corner of Lot 1419; thence southerly in a straight line to the north east corner of Lot 494; thence southerly along the easterly boundary of Lot 494 to the north west corner of Lot 487A; thence easterly and southerly along the northerly and easterly boundaries of Lot 487A to the south east corner thereof; thence easterly along the northerly boundaries of Lots 398 and 403 to the north east corner of Lot 403; thence southerly along the easterly boundary of Lot 403 to the north west corner of Lot 405; thence easterly along the northerly boundary of Lot 405 to the north east corner thereof; thence easterly and southerly along the northerly and easterly boundaries of Lots 1385, 1321, 1314 and 420 and the West 1/2 of Lot 442 to the south east corner of the said West 1/2 of Lot 442; thence easterly along the southerly boundaries of Lots 442 and 1311 to the south east corner of Lot 1311; thence northerly along the easterly boundaries of Lots 1311 and 1312 to a point due west of the south west corner of Lot 628; thence east to said corner; thence easterly and northerly along the southerly and easterly boundaries of Lot 628 to the north east corner thereof; thence due north to a point on the high water mark of the southerly shore of Kennedy Lake; thence North 80° East to a point due north of the north east corner of Lot 63; thence south to said corner; thence southerly along the easterly boundary of said Lot 63 to the northerly boundary of T.L. 2924P; thence westerly and southerly along the northerly and westerly boundaries of said T.L. 2924P to a point due east of the most southerly south east corner of Lot 63; thence west to said corner; thence westerly along the southerly boundary of said Lot 63 to the easterly boundary of Lot 71; thence southerly along the easterly boundaries of Lots 71 and 72 to the most westerly south west corner of T.L. 10793P; thence due west to the

easterly boundary of Lot 64; thence southerly along the easterly boundary of said Lot 64 to the south east corner thereof; thence due south to a point due east of the north east corner of Lot 1310; thence west to said corner; thence southerly along the easterly boundary of said Lot 1310 to the south east corner thereof; thence southerly, westerly and southerly along the easterly, southerly and easterly boundaries of T.L. 10790P to a point due east of the south east corner of T.L. 10789E; thence west to said corner; thence due south to the northerly boundary of Lot 404; thence westerly along the northerly boundary of said Lot 404 to the north east corner of Lot 483; thence southerly and westerly along the easterly and southerly boundaries of Lots 483 and 462 to the south west corner of Lot 462; thence southerly along the easterly boundaries of Lots 464 and 467 to a point due east of the north east corner of Indian Reserve No. 7; thence west to said corner; thence westerly along the northerly boundary of said Indian Reserve No. 7 and the westerly prolongation thereof to a point on the high water mark of the Pacific Ocean on the westerly shore of Vancouver Island south of Florencia Bay; thence west 1.5 miles; thence North 40° West 7 miles; thence west 4.8 miles; thence North 40° West 2.6 miles; thence North 1.4 miles more or less to a point due west of the north west corner of Lot 1360; thence east to said corner; thence easterly along the northerly boundaries of Lots 1360, 256, 255, 254, 253, 250, 249, 251 and 252 to the north east corner of Lot 252; thence southerly along the easterly boundary of said Lot 252 to the north west corner of Lot 235; thence easterly along the northerly boundaries of Lots 235, 234, 233, 232, 231 and 198 to the north east corner of Lot 198, being the apoint of commencement.

AND TO FURTHER RECOMMEND THAT upon the expiry of any mineral claim, placer-mining claim or lease which lies within the area outlined above, the lands covered by any such mineral claim, placer-mining claim or lease shall become and are hereby constituted a reservation under the terms of this Order.
