EXECUTIVE COUNCIL CHAMBERS, VICTORIA AUG. 7 1975

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council,

*orders that*

- (1) no person shall locate upon and no free miner shall stake on any of the lands within the area described in Schedule "A" attached hereto and made a part hereof which lands are situated in the Cariboo Mining Division, Cariboo Land District;
- (2) upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in the right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall locate upon and no free miner shall stake on such lands;

and

- (3) with respect to the Placer Mining Act the lands described in Schedule "A" above are hereby designated as placer reserves.

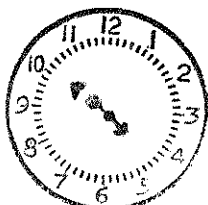

This is Schedule "A" which forms part of Order-in-Council No. \_\_\_\_\_

Commencing at a point on the natural boundary of Chilcotin River, on the left bank thereof, said point being the southwest corner of Lot 701; thence northerly along the westerly boundary of said Lot 701 to the northwesterly corner thereof; thence due north 62 chains more or less to a point due east of the southeasterly corner of Lot 9191; thence due west 118 chains more or less to the aforesaid southeasterly corner of Lot 9191; thence westerly along the southerly boundary of said Lot 9191 to the southwesterly corner thereof; thence due west 3 chains more or less to a point on the natural boundary of Chilcotin River, on the left bank thereof; thence southerly and easterly along said left bank of Chilcotin River to the aforesaid southwest corner of Lot 701, being the point of commencement, containing 560 acres more or less.
