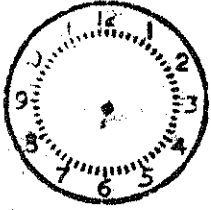

EXECUTIVE COUNCIL CHAMBERS, VICTORIA -5. MAY 1977

Pursuant to the Mineral Act and Placer Mining Act, and upon the recommendation

of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

(1) no person shall record or locate upon and no free miner shall stake on any of the lands within the following described areas in the Vancouver Mining Division, New Westminster, Group 1 Land District, in the period commencing on the date this order comes into force and terminating December 31, 1978:

1. Commencing at a point on the westerly boundary of Garibaldi Park, said point being located 200 m south of a corner of the said boundary, said corner being located immediately north of the intersection of the said boundary with the Cheakamus River, thence due west 2 350 m, thence due south 3 040 m more or less to the westerly boundary of Garibaldi Park, thence easterly and northerly along the said boundary to the point of commencement and containing 705 ha more or less (1745 acres).
2. Commencing at a point on the westerly boundary of Garibaldi Park, said point being located 1 800 m south of a corner of the said boundary, said corner being located immediately north of the intersection of the said boundary with Rubble Creek, thence due west to the most westerly easterly boundary of Lot 6421, N.W.D., thence southerly along the said easterly boundary to the most southerly southeast corner thereof, thence due south 700 m, thence S 45° E 3 460 m more or less to the westerly boundary of Garibaldi Park, thence northerly along the said westerly boundary 3 420 m more or less, to the point of commencement and containing 530 ha more or less (1320 acres).

(2) upon the expiry of the term or cancellation of any existing mineral claim, placer claim or lease, or lease issued under the Mineral Act or upon the reversion to the Crown in right of the Province of any Crown-granted mineral claim the lands formerly contained in these instruments which fall within the above area shall immediately upon such expiry or cancellation or reversion become subject to this order and no person shall record or locate upon and no free miner shall stake on such lands;

and

(3) with respect to the Placer Mining Act the lands described above are hereby designated as placer reserves.
