On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

1. The following described lands in the Golden, Fort Steele and Slocan Mining Divisions, Kootenay Land District, are established as a mineral reserve and as a placer mining reserve until April 30, 1983.
 - (1) Lots 49, 50, 52, 58 and 60, District Lot 3464, Plan 949 as filed in the Land Titles Office, Nelson.
 - (2) All that portion of Block A of Lot 325, Plan X-16 lying west of Plan R-181 and lying east of Plan 524 R-1.
 - (3) Parcels A & B of Block 7, Lot 377, Plan 12049 as filed in the Land Titles Office, Nelson.
 - (4) That portion of Lot 377, Plan 692 as filed in the Land Titles Office, Nelson, described as follows:

Commencing at the northeast corner of lot 20, block 17; thence southerly along the east boundaries of lots 20 to 11 inclusive of block 17 and the southerly prolongation thereof to the northeast corner of lot 20, block 20; thence easterly in a straight line to the northwest corner of lot 1, block 19; thence easterly along the north boundary of the said lot 1, block 19 and the easterly prolongation thereof and the north boundary of lot 20, block 19 and the easterly prolongation thereof to the northwest corner of lot 1, block 18 to the northeast corner thereof; thence southerly along the east boundaries of lots 1 to 10 inclusive of block 18 and the southerly prolongation thereof to the northeast corner of lot 1, block 33; thence southerly along the east boundaries of lots 1 to 10 inclusive of block 33 to the southeast corner of the said lot 10, block 33; thence westerly along the south boundaries of lot 10 of block 33, lots 10 & 11 of block 32, lots 10 & 11 of block 31 and lot 11 of block 30 and the westerly prolongations thereof to the southeast corner of lot 10, block 30; thence westerly along the south boundary of the said lot 10, block 30 to the southwest corner thereof; thence northerly along the west boundaries of lots 10 to 1 inclusive of block 30 to the northwest corner of the said lot 1, block 30; thence easterly along the north boundaries of lots 1 and 20 and the easterly prolongations thereof to the northwest corner of lot 1, block 31; thence northerly in a straight line to the southwest corner of lot 10, block 20; thence northerly along the west boundaries of lots 10 to 1 inclusive of block 20 to the northwest corner of the said lot 1, block 20; thence northerly in a straight line to the southwest corner of lot 10, block 17; thence northerly along the west boundaries of lots 10 to 1 inclusive of block 17 to the northwest corner of the said lot 1, block 17; thence easterly along the north boundary of lot 1, block 17 and the easterly prolongation thereof and the north boundary of lot 20, block 17 to the northeast corner of the said lot 20, block 17, being the point of commencement.
