EXECUTIVE COUNCIL CHAMBERS, VICTORIA FEB. 26. 1981

On the recommendation of the undersigned, the ^{Administrator} ~~Lieutenant-Governor~~, by and with the advice and consent of the Executive Council, orders that

1. The following described land in the Atlin Mining Division, Cassiar Land District, is established as a mineral reserve and as a placer mining reserve until March 1, 1983.

An area 1 000 m wide being 500 m on each side of the center line of the proposed Adanac Molybdenum Power Canal as described:

Commencing at the point of intersection of the northerly prolongation of the easterly boundary of lot 249 with the natural boundary of Surprise Lake on the southerly shore thereof; thence S 62° W 4 500 m; thence S 47° W 1 350 m; thence N 83° W 2 400 m; thence S 75° W 1 600 m; thence S 14° E 800 m; thence S 18° W 850 m; thence S 61° W 2 200 m; thence S 23° W 1 300 m; thence S 47° W 2 050 m; thence S 2° E 400 m; thence southwesterly 800 m, more or less, to the point of intersection of the natural boundary of Atlin Lake on the easterly shore thereof, with the natural boundary of an unnamed creek on the right bank thereof, said unnamed creek flowing westerly into Atlin Lake at a point 375 m, more or less, due west and 250 m, more or less, due north to the northwest corner of lot 1106.

2. No free miner shall obstruct, endanger or interfere with or allow any other person to obstruct, endanger or interfere with the construction, operation or maintenance of Adanac Molybdenum Power Canal in the reserve created by section 1.
