EXECUTIVE COUNCIL CHAMBERS, VICTORIA FEB.-5.1982

On the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that

- 1. The following described land in the Similkameen Mining Division, Yale Division of Yale Land District, is established as a mineral reserve and as a placer mining reserve.

Commencing at the southwest corner of Lot 876, Yale Division of Yale District, thence to a point lying 625 meters easterly on the southerly boundary of said Lot 876; thence due south 205 meters more or less to the natural boundary of Tulameen River on the left bank thereof; thence 1 425 meters more or less westerly to the point of intersection with the westerly boundary of Lot 877 Yale Division of Yale District; thence northerly along the westerly boundary of said Lot 877 a distance of 205 meters; thence due west a distance of 220 meters; thence due north to the point of intersection with the natural boundary of Tulameen River on the left bank thereof; thence in a general easterly direction along the natural boundary of Tulameen River on the left bank thereof, to the point of intersection with the westerly prolongation of the south boundary of Lot 876, Yale Division of Yale District; thence easterly to the southwest corner of said Lot 876, being the point of commencement.

- 2. No free miner shall stake or acquire a location or record or locate a mineral claim on land in the reserve created by section 1.
