On the recommendation of the undersigned, the ~~Lieutenant-Governor~~, by and with the advice and consent of the Executive Council, orders that the following described area in the Cariboo Mining Division, Cariboo Land District, be and are hereby designated as designated placer land.

Commencing at the southwest corner of Lot 1660; thence northerly along the westerly boundaries of Lot 1660 and 1658 to the southwest corner of Lot 1852; thence northerly along the westerly boundary of Lot 1852 a distance of 800 m; thence easterly and parallel to the southerly boundary of Lot 1852 and the easterly prolongation thereof to the point of intersection with the natural boundary of the Fraser River on the left bank thereof; thence in a generally southeasterly direction along the natural boundary of Fraser River on the left bank thereof to the point of intersection with the northerly prolongation of the easterly boundary of Lot 4611; thence southerly along the said northerly prolongation and the easterly boundary of Lot 4611 to the southeast corner thereof; thence westerly along the southerly boundaries of Lots 4611 and 4610 to the southwest corner of Lot 4610; thence southerly along the easterly boundary of Lot 1856 to the southeast corner thereof; thence westerly along the southerly boundaries of Lot 1856 and 1660 to the southwest corner of Lot 1660, being the point of commencement.
