On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

1. B.C. Regulation 111/78 be repealed.
2. The following described lands in the New Westminster and Nicola Mining Divisions, Yale Division of Yale and Kamloops Division of Yale Land District are established as a mineral reserve and as a placer mining reserve until December 31, 1988.

An area 600 metres wide being 300 metres on each side of the centre line of the right of way of the proposed Coquihalla Highway as shown in blue on the accompanying map.

3. A free miner may locate or record a mineral claim or stake or acquire a location on all or part of the land in the mineral reserve and placer mining reserve subject to the following conditions:

No free miner shall obstruct, endanger or interfere or allow any other person to obstruct, endanger or interfere with the construction, operation or maintenance of a transmission line, pipeline or other work, structure or activity on all or part of the land in the mineral reserve and placer mining reserve.
