On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

- 1. B.C. Reg. 56/85 is repealed.
- 2. The following described lands in the Victoria Mining Division, Metchosin Land District, are established as a mineral reserve and as a placer mining reserve:

Bearings are astronomic as in land title office plans 35183, 36378 and 38347. Commencing at the iron post located at the most northwesterly corner of Part of Lot 6, Plan 36378, Section 110, Metchosin Land District; thence on a bearing of 208°53'40" for a distance of 196.835 metres; thence on a bearing of 273°45'00" for a distance of 168.615 metres; thence on a bearing of 338°35'00" for a distance of 84.235 metres; thence on a bearing of 210°32'40" for a distance of 25.445 metres; thence on a bearing of 158°35'00" for a distance of 71.025 metres; thence on a bearing of 213°08'50" for a distance of 194.32 metres; thence on a bearing of 172°43'55" for a distance of 138.84 metres; thence on a bearing of 150°41'40" for a distance of 112.97 metres; thence on a bearing of 90°50'00" for a distance of 30 metres, more or less, to the most southerly iron post located in the southwest corner of Part of Lot 6, Plan 36378, Section 110, Metchosin Land District; thence on a bearing of 90°50'00" for a distance of 31.99 metres; thence on a bearing of 113°05'20" for a distance of 72.44 metres; thence on a bearing of 91°24'30" for a distance of 128.70 metres; thence on a bearing of 109°13'20" for a distance of 44.25 metres; thence on a bearing of 28°20'00" for a distance of 415.56 metres; thence northeasterly to the iron post located at the most easterly boundary of Lot 6, Plan 35183, Section 103, Metchosin Land District; thence on a bearing of 358°17'20" for a distance of 214.22 metres; thence on a bearing of 257°07'50" for a distance of 86.87 metres; thence on a bearing of 300°42'40" for a distance of 53.64 metres; thence southwesterly to the iron post located at the most northwesterly corner of Part of Lot 6, Plan 36378, Section 110, Metchosin Land District, being the point of commencement.

- 3. No Free Miner shall stake or acquire a location or record or locate a mineral claim in the reserve created by section 1.
