On the recommendation of the undersigned, the Lieutenant Governor, by and with the advice and consent of the Executive Council, orders that

1. B.C. Reg. 152/86 be repealed.
2. The following described land in the Cariboo Mining Division, Cariboo Land District be and hereby is designated as designated placer land:

All that area of the Fraser River watershed 1000 m on either side of the middle line of the Fraser River upstream from the point of intersection with the Easterly prolongation of the Northerly boundary of Lot 817 and downstream of the point of intersection with the Northwesterly boundary of the Crescent Spur Designated Placer Area as described in B.C. 
