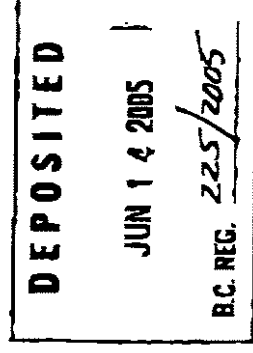

REGULATION OF THE CHIEF GOLD COMMISSIONER

Mineral Tenure Act and Coal Act

I, Gerald German, Chief Gold Commissioner, Ministry of Energy and Mines, order that

1. A reserve is established for minerals and placer minerals over the lands described in B.C. Reg. 210/2005.
2. A free miner must not register a mineral or placer claim in the reserve established by section 1.
3. The areas described in section 1 are established as a coal land reserve.
