REGULATION OF THE CHIEF GOLD COMMISSIONER

Mineral Tenure Act; Coal Act

I, May Mah-Paulson, Chief Gold Commissioner, Ministry of Energy and Mines, order as follows:

- 1 B.C. Reg. 233/2001 is amended as set out in section 1 of the attached Schedule.
- 2 (1) The mineral and placer mineral reserves and coal land reserves established by B.C. Reg. 82/2004 over site 402579, WINDY RIDGE WIND PARK, and site 402582, NIMPKISH WIND PARK - SITE 2, are cancelled and B.C. Reg. 82/2004 is amended by deleting the corresponding sketches.
(2) B.C. Reg. 287/88 applies to the land, including foreshore and land covered by water, that, immediately before this section came into force, was within the area of a site referred to in subsection (1).


