

## 2022 PSO Climate Change Accountability Report

**Organization:** School District No 75 (Mission)

**Declaration statement:** This PSO Climate Change Accountability Report for the period January 1, 2022 to December 31, 2022 summarizes our greenhouse gas (GHG) emissions profile, the total offsets to reach net-zero emissions, the actions we have taken in 2022 to minimize our GHG emissions, and our plans to continue reducing emissions in 2023 and beyond.

### Emission Reductions: Actions & Plans

In 2022, several actions were taken to reduce GHG emissions, which included:

- Boiler and pumping system upgrade at Stave Falls Elementary
- Roofing upgrades at Stave Falls Elementary
- Shift from paper to digital time sheets for staff

Looking forward to 2023 and beyond, several projects are expected to complete, and new projects expected to be initiated, that will further reduce GHG emissions:

- HVAC upgrades at West Heights, Albert McMahon, Christine Morrison, and Cherry Hill elementary schools
- Replacement of buses with electric models or more fuel-efficient models
- Electrical upgrades at various schools
