PRIMARY FUNCTION

To examine applications involving construction or development within Highway right of ways, access to and from Highways and District roads, and applications for subdivisions, rezoning or works on Crown Lands and to ensure approvals are in the public interest and based upon transportation engineering principles.


JOB DUTIES AND TASKS

- 1. Examines applications for the subdivision of land outside municipalities and land adjacent to controlled access highways within municipalities
 - a. examines preliminary plans submitted by applicants and compares the plans against the provisions of existing legislation, bylaws, regulations and policies and the concerns of local governments
 - b. confirms plans for access to surrounding property, water and utilities
 - c. determines the classification of roadways and right of way requirements such as whether an additional right of way is required to accommodate road construction or widening
 - d. examines plans to ensure standards for road design and utilities have been addressed
 - e. identifies geotechnical conditions that could affect the development proposal
 - f. examines surrounding land area to determine conditions and compatible land uses
 - g. surveys and confirms title of property and status of covenants or charges against the property
 - h. informs applicants of the requirement for further information or professional studies and reviews results
 - i. prepares technical reports on proposals for the Provincial Approving Officer or District Manager including a recommendation either to grant or deny approval
 - j. conducts site inspections to assess applications, to ensure road and drainage requirements outlined in the preliminary approval are being met and survey pins, posts and monuments have been installed as required
 - k. refers proposals to other agencies for evaluation and assesses recommendations made
 - I. receives and accepts final subdivision plans for assessment to ensure that all requirements of preliminary approval have been addressed by the plans
 - m. approves applications for highway access and related section 57 provisions and sets conditions on the approval without reference to a higher authority
 - n. discusses proposals and alternative options with applicants, stakeholders and outside agencies to gain consensus on acceptable compromises and solutions to ensure compliance with legislation, bylaws, regulations and policies
 - o. negotiates changes to original applications and sets conditions on approval
- 2. Examines applications for development, construction, utility or other works on Crown Lands

- a. accepts referrals from agencies such as the Ministry of Environment and the Ministry of Forests
- b. determines feasibility and adequacy of proposals for highway and site access
- c. ensures condition of land is compatible with proposed use and surrounding land use
- d. ensures development applications are consistent with Crown interests and protect future highway corridors and plans
- e. receives applications and examines plans to ensure that offsets comply with requirements
- f. conducts pre and post site inspections to determine and ensure that requirements are met

3. Performs other related duties

- a. evaluates rezoning applications according to applicable sections of the Highway Act
- b. enforces ministry sign policy and advises applicants on regulations for the display of signs
- c. conducts site inspections to follow-up on all types of requests and applications
- d. logs and tracks development applications on a computerized system
- e. accepts cheques and letters of credit for bonding purposes and acts as the payment authority for the return of bonds upon certification that applicable standards and conditions have been met
- f. represents the Ministry at traffic impact studies and/or pre-construction meetings
- g. grants gravel extraction permits and collects applicable fees
