Amendment to The Ch-ihl-kway-uhk Tribe **Forest Agreement** (the Agreement) Between Ch-ihl-kway-uhk Tribe and Ch-ihl-kway-uhk Forestry Limited Partnership and Government of British Columbia Dated March 30, 2004

In accordance with section 11.0 of the Agreement, the Ch-ihl-kway-uhk Tribe, the Ch-ihl-kway-uhk Forestry Limited Partnership and the Government of British Columbia hereby amend paragraph 3.3.3.4 of the Agreement by adding after "controlling interest" at the end of the paragraph, "except that a controlling interest is not necessary for a transfer in good faith of an interest in the licence by way of a security interest to a secured creditor, or a disposition of the licence to the secured creditor in accordance with the security agreement.
