Re: Transition for Cutting Permits in effect on November 4, 2003

On November 25, 2021, Section 58.2 of the *Forest Act* was repealed and new Section 58.201 was added:

- Section 58.201 applies to all legacy cutting permits (CPs), those that were issued on or before November 4, 2003, which remained in effect on November 25, 2021.
- Section 58.201 (2) prohibits further extensions of these legacy CPs.
- Section 58.201 (3) extends the term of any grand-parented CPs that were to expire before November 25, 2022, to that date. Legacy CPs that expire after November 25, 2022, will expire on the date within the CP.
- Section 58.201 prohibits postponement of any legacy CP that remained in effect on November 25, 2021.

Legacy CPs are permits issued before November 4, 2003, under the *Forest Practices Code of BC Act* that were continued under the new *Forest and Range Practices Act* to ensure timber flow and job stability. The government has determined that these legacy CPs should be phased out to ensure future authorizations are consistent with government's responsibility and commitment to reconciliation with our Indigenous Nations. Legacy CPs may not be postponed or extended after November 25, 2021, and expire on November 26, 2022, or the date within the CP, whichever is longer. All obligations associated with the CP continue until they have been met and outstanding fees, assessments and penalties must be paid upon cancellation of the associated CP.

Regional Executive Directors District Managers

For CPs with an expiry date greater than two years since the date of the previous expiration date, the following is recommended:

- 1. Determine the appropriate expiration date, either two years from the date of the previous expiration date or November 25, 2022, whichever is greater.
- 2. Notify affected CP holders that the CP was extended for a term greater than what was permitted under the now repealed *Forest Act*, Section 58.2, and a new CP with a new expiration date will be issued (see attached template).
- 3. Re-issue the CP with the corrected expiration/extension date to the CP holder.
- 4. Update the CP expiration and extension date in the FTAS.

District managers are requested to notify affected CP holders (Appendix A) on the status of these CPs and their expiration date. Please refer to the attached sample letter (Appendix B) for contacting affected CP holders. District staff are requested to update the Forest Tenures Administration System information as required.

In accordance with Section 58.201 of the *Forest Act*, which came in effect on November 25, 2021, the cutting permits that were issued on or before November 4, 2003, and expire on or before to November 24, 2022, listed in the table 1 below will be cancelled on November 26, 2022. Cutting permits that expire were issued on or before November 4, 2003, and expire after November 25, 2022, expire on the date of the cutting permit as listed in table 1 and 2 (if applicable). These cutting permits cannot be extended or postponed. All obligations associated with the cutting permits continue until they have been met.

As the holder of the cutting permit, you will be required to complete all assessments and pay all associated fees and penalties associated with each cutting permit. The Forest Tenures Administration information has been updated to the legislative date.
