#### WHEREAS:

- A. Pursuant to the provisions of the *Forest Act*, the Licensor and Licensee entered into a replacement agreement for Tree Farm Licence 60, dated January 15, 2010,
- B. The Licensee has provided consent, dated October 8, 2010, to delete 27,379 ha of Crown land identified on the attached maps from Tree Farm Licence 60 and,
- C. On the effective date of this Instrument, Minister's Order Number 3(4)(b) 7-1 deleted 35,324 ha of Crown land from TFL 60 representing an AAC of 174,254 m<sup>3</sup>.

### THEREFORE:

- 1. In accordance with Section 39.1(1) of the *Forest Act*, the Licensor, with the consent of the Licensee, hereby changes the boundary and area of Tree Farm Licence 60 by removing the area (27,379 ha), outlined in black on the attached maps 1 of 2 and 2 of 2, from Tree Farm Licence 60 as of the effective date of this instrument.
- 2. For the purpose of Section 10 (1) of the *Allowable Annual Cut Administration Regulation*, the AAC associated with the area deleted under '1' above is 105,494 m<sup>3</sup>.
- 3. Paragraph 2.01 of Tree Farm Licence 60 is deleted and replaced with the following:
  - 2.01 Each year during the term of this Licence:
    - (a) 0 m<sup>3</sup> of the allowable annual cut, from the types of timber specified under Paragraph 1.02(a) may be disposed of by the Timber Sales Manager within areas agreed to under Paragraph 3.01 or specified under Paragraph 3.02;
    - (b) 0 m<sup>3</sup> of the allowable annual cut may be disposed of pursuant to Section 47.8 of the *Forest Act*.
