Responsibilities for Sellers and Purchasers:

Sellers – this certificate allows you to collect the information required to substantiate a partial exemption under the Carbon Tax Act.

Obtain a completed copy of this certificate at or before the time of the sale and keep it in your records to support your partial collection of tax on the sale.

If you do not receive a completed copy of this certificate at or before the time of the sale, you must not grant the partial exemption. Granting the partial exemption without obtaining a completed copy of this certificate may result in an assessment, penalty and interest.

Purchasers – you are responsible for ensuring that you meet all the requirements of the partial exemption under the Carbon Tax Act.

Complete a copy of this certificate and provide it to the seller at or before the time of the sale.

If you complete the partial exemption certificate but do not qualify for the exemption, you are responsible for paying the tax as applicable.

By signing this form, I certify that:

- the purchaser identified above is an eligible greenhouse grower and the information provided is correct, and
- the fuel will be used for heating the eligible greenhouse or for supplementing carbon dioxide in the greenhouse to grow or produce plants

I acknowledge that if I make a false statement to avoid paying tax, the Carbon Tax Act charges a fine of up to \$10,000 and/or imprisonment up to two years, in addition to a penalty of 25% of the tax due and an assessment for the tax that should have been paid.
