What sets of data are included in SLRP? This includes spatial data for Landscape Units, Old Growth Management Areas, Strategic Land and Resource Plan Boundaries, Legal Planning Objectives & Non-Legal Planning Features.

Landscape Units - a spatially identified area of land &/or water used for long-term planning resource management activities. **OGMAs** - legal and non-legal old growth management areas.

Strategic Land & Resource Plan Boundary - legal & non-legal Plan boundaries from emerging SLRP processes through the Province. Legal Planning Objectives—legal objectives that are enabled through the Land Act & have emerged from SLRP processes. Non-Legal Planning Features - non-legal planning features that have emerged from SLRP processes thought the Province.



Discovering SLRP Data

Metadata records for each SLRP feature type have been created in the GeoBC Discovery Service.. The Discovery Service is found at https://apps.gov.bc.ca/pub/geometadata/home.do.

Each SLRP topic can be queried from this service. A quick way to find all of the topics is to enter the search criteria:



Downloading SLRP Data

All current SLRP data has been configured with the GeoBC Data Distribution Service. The Distribution Service is found at https://apps.gov.bc.ca/pub/dwds/home.so. Each data user can also connect to the Distribution Service through the Discovery Services' metadata record, by clicking on the "Download Data" button towards the top right corner.

Each current SLRP topic can be ordered in **shapefile** format from this service.

Legal Planning Objectives & Non-Legal Planning Features Attribute Details

The respective data models use overlapping points, lines or polygons to show all of the legal or non-legal features within one respective set of data, i.e. all strategic land and resource plans throughout the province with non-legal polygon objectives will be contained within one set of data; and all strategic land and resource plans throughout the province with legal polygon objectives will be contained within one set of data. The point and linear features are also managed using the same overlapping model. This means that the data user must run a query on the database to select and/or extract only the desired data. 30 PAIRED ATTRIBUTES:

Each objective has unique attribute information. To store all of the objectives in one dataset the data was modelled to have attribute pairs to support the attribute name and attribute value. A particular objective can have up to 30 additional attribute pairs. Change Management Process

SLRP data is modelled to track all spatial and tabular changes overtime. Therefore, a series of change management attributes were created to store information about the changes. Through database queries, a data user can report on how a feature has changed overtime.

Each SLRP feature class includes 8 change management attributes to track incremental changes and updates to SLRP data, including tracking of features overtime.

	Attribute Name	Attribute Description
"CURRENT" and "ALL" views	GIS Change Date	A date field to indicate the date that a spatial feature was digitized and uploaded to the Geographic Warehouse by the "GIS Change Person".
	GIS Change Person	A text field to indicate the technical GIS person who physically made an addition or changed a SLRP spatial feature that.
	Change Reason	A text field to indicate the business reason for initiating a change to a SLRP spatial feature.
	Initiator of Change	A text field to indicate the person in the business area who requested change(s) to be made.
"ALL" views only	Retirement Date	A date field to indicate when a SLRP spatial feature has been retired (if applicable).
	Retirement GIS Change Person	A text field to indicate the technical GIS person who physically retired a SLRP spatial feature.
	Retirement Reason	A text field to indicate the business reason for retiring a SLRP spatial feature.
	Retirement Initiator of Change	A text field to indicate the person in the business area who has requested that spatial features be retired.
