#### **Pan-Canadian Framework**

The Pan-Canadian Framework on Clean Growth and Climate Change plan is now finalized and posted. This is the collective plan between Canada's federal, provincial and territorial governments to grow our economy while reducing emissions and building resilience to adapt to a changing climate. It is Canada's plan to address climate change and grow the clean economy.

- 1. Setting ambitious targets to reduce emissions from government operations
- 2. Cutting emissions from government buildings and fleets
- 3. Scaling up procurement

BC's carbon neutral government commitment is spotlighted in the plan.
