Re: Changes to Serving It Right (SIR) training requirements and introduction of new Special Event Server (SES) certification for special occasion licensed (SOL) event staff

IMPORTANT: ALL CHANGES IN THIS POLICY DIRECTIVE ARE EFFECTIVE SEPTEMBER 15, 2015

Introduction

At the end of January, 2014, government announced acceptance of the recommendations of the Liquor Policy Review Report, including changes (recommendation (#7) affecting the mandatory training requirements for those selling or serving liquor to the public. Background

Serving It Right: The Responsible Beverage Service Program is a self-directed training course managed by go2hr, an independent, non-profit human resources association of the BC tourism and hospitality industry. The SIR program contains information about the obligations that accompany the sale or service of liquor, along with helpful tips to meet those obligations (for full course details, see http://www.servingitright.com/.) The course may be completed either online or by mail.

Under the current rules, licensees, managers, and servers in many types of establishments where liquor is served or sold directly to the public must have SIR certification, although there are some exemptions.

New Regulatory Requirements and Policy

1. Changes to Serving It Right (SIR) mandatory training requirements

The new SIR training requirements will provide consistency so that:

- Licensees:
- managers (staff who supervise the service or sale of liquor); and
- servers (staff who sell or serve liquor)

at all licensed establishments, all liquor retail stores, and large SOL events (500 or more people attending) that sell directly to the public are subject to the same SIR training requirement. Current policy and changes are summarized in Table 1.

Table 1: Summary of SIR Training Requirements by Licence Type (with changes shaded in grey)

Caterer	SIR certificate is required for all licensees, managers, and servers. No exemptions.	No changes. SIR certificate is required for all licensees, managers, and servers.

Wine Store	Licensee, managers, and servers are exempt.	SIR certificate is required for all licensees, managers and servers of all wine stores, with the exception of sacramental wine stores.		
Government Liquor Store	Store managers and servers are exempt.	Remove exemption. SIR certificate is required for all store managers and servers.		
Rural Agency Store	Agents and servers are exempt.	Remove exemption. SIR certificate is required for all agents and servers.		
Duty Free Store	Managers and servers are exempt.	Remove exemption. SIR certificate is required for all managers and servers, with the exception of ship chandlers.		
Manufacturer Sampling Areas and Endorsement Areas (Lounge and Special Event Areas)	SIR certificate is required for all licensees, managers, and servers. No exemptions.	No changes. SIR certificate is required for all licensees, managers, and servers.		
Ferment on Premise	Licensee, managers and staff are exempt.	No changes. SIR certificate is not required.		
Special Occasion Licences (SOL)	SIR certificate is required for all licensees, managers, and servers, except for family SOL event holders and unpaid servers.	SIR certificate is required for licensees and managers of SOL events (of any type) with 500+ people attending. Note: Certification requirements for licensees, managers, and servers at small SOL events (with less than 500 people attending), are described in Table 2 below.		

2. Introduction of new Special Event Server (SES) Mandatory Training Program for SOL Events

A new, abridged SES training program is being developed specifically for SOL events and is expected to be launched in June, 2015 to provide sufficient time for people to meet the training requirement by the September 15, 2015 deadline. The new program will ensure that all servers at all types of SOL events receive training by removing exemptions for licensees/managers of family SOL events and for unpaid servers at all types of SOL events.

The new SES training will be required for:

- SOL licensees, managers, and servers of events with under 500 attendees; and
- All SOL servers (paid or unpaid), regardless of the size or type of SOL.

Table 2 summarizes the changes to the mandatory training requirements for SOL holders.

3. Exemptions from the SIR and SES Mandatory Training Requirements

Anyone holding a valid SIR certificate is exempt from the new SES training requirement.

Any servers holding valid SIR-equivalent certificates from other Canadian jurisdictions continue to be exempt from the SIR and SES training requirement. SOL licensees and managers at small events (less than 500 people attending) holding valid SIR-equivalent certificates from other Canadian jurisdictions are exempt from the SES training requirement.

Certificates from other jurisdictions with no expiry date will be deemed expired and will no longer be accepted after December 15, 2020.

4. Expiry of SIR and SES Certificates and Recertification

Existing SIR certificates (with no expiry date on them) will be deemed expired on September 15, 2020 and certification must be renewed before that date. This allows more than 5 years for current certificate holders to obtain recertification. Effective September 15, 2015, new SIR certificates will be issued with an expiry date.

Both SIR and the new SES certificates must now be renewed on an ongoing basis every 5 years.

5. SIR and SES fees

Current fees for SIR training are \$35 and \$40 for the online and print versions respectively. The current SIR certificate renewal fee is \$10.

Fees for SIR and the new SES are currently under review and announcements will be made in early 2015.
