## IN THE MATTER OF TREE FARM LICENCE 1 **INSTRUMENT NUMBER 103**

Amendment

THIS AGREEMENT is made effective the day of, 2011
BETWEEN:
THE MINISTER OF FORESTS, LANDS and NATURAL RESOURCES OPERATIONS, on behalf of HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA Parliament Buildings Victoria, British Columbia V8V 1X4
(the "Licensor")
AND:
COAST TSIMSHIAN RESOURCES LIMITED PARTNERSHIP 4905 Keith Avenue Terrace, BC V8G 4B1
(the "Licensee")
WHEREAS:

- A. Pursuant to the provisions of the *Forest Act*, the Licensor and Licensee entered into a replacement agreement for Tree Farm Licence 1, dated January 1, 2008,
- B. The Licensee has provided consent on January 5, 2011, to delete 93,959 ha of Crown land identified on the attached maps from Tree Farm Licence 1 and,

- C. The Licensee and the Licensor agree that the allowable annual cut (AAC) associated with the area referred to in 'B' is 121,941 m3/year, of which:
  - 29,950 m3/year represents the reservation in Paragraph 2.01(a) of the TFL
     1 licence agreement, established in accordance with Section 35(1)(h) of the Forest Act;
  - 91,991 m3/year represents the reservation in Paragraph 2.01(b) of the TFL 1 agreement and accounts for an AAC reduction in accordance with Section 3(3) of the *Forestry Revitalization Act*, Order # 3(2) 15-3.

### THEREFORE:

- 1. On the effective date of this Instrument, Minister's Order Number 3(4)(b) 15-1 deleted 82,801 ha of Crown land from TFL 1 representing an AAC of 91,991 m<sup>3</sup>.
- 2. In accordance with Section 39.1(1) of the *Forest Act*, the Licensor, with the consent of the Licensee, hereby changes the boundary and area of Tree Farm Licence 1 by removing the area (11,158 ha), outlined in black and coloured red on the attached maps 1 of 1, from Tree Farm Licence 1 as of the effective date of this instrument.
- 3. For the purpose of Section 10 (1) of the *Allowable Annual Cut Administration Regulation*, the AAC associated with the area deleted under '2' above is 29,950 m<sup>3</sup>.
- 4. Paragraph 2.01 of Tree Farm Licence 1 is deleted and replaced with the following:
  - 2.01 Each year during the term of this Licence:
    - (a) 0 m<sup>3</sup> of the allowable annual cut, from the types of timber specified under subparagraph 1.02(a) may be disposed of by the Timber Sales Manager within areas agreed to under Paragraph 3.01 or specified under Paragraph 3.02;
    - (b) 28,791 m<sup>3</sup> of the allowable annual cut may be disposed of in accordance with a disposition plan approved by the Minister pursuant to Section 47.8 of the *Forest Act*.
    - (c) 28,991 m<sup>3</sup> of the allowable annual cut may be disposed on in accordance with a disposition plan approved by the Minister.
