

EXECUTIVE COUNCIL CHAMBERS, VICTORIA 10. FEB. 1978

Pursuant to the Placer Mining Act, and upon the recommendation of the undersigned, the Lieutenant-Governor, by and with the advice and consent of the Executive Council, orders that the following described area in the New Westminster Mining Division, Yale Division of Yale Land District, be and is hereby designated as designated placer land.

Commencing at the southeast corner of I.R. 3, "Kuthlalth", thence due east 7 km; thence due north 6 850 m more or less to the south boundary of Tp 8 R 25 W6M; thence due west on said south boundary of Tp 8 R 25 W6M and the south boundary of section 11, Tp 8 R 26 W6M to the natural boundary of the east bank of the Fraser River; thence generally southerly on the said natural boundary of the east bank of the Fraser River to the north boundary of I.R. 3, "Kuthlalth"; thence easterly and southerly on the north and east boundaries of said I.R. 3, "Kuthlalth", to the southeast corner thereof, being the point of commencement.


