Executive Summary

In the fall of 2011, Vancouver Community College (VCC) launched a new three-year Strategic Plan with a vision to create an accessible urban college that engages with the many diverse communities within the Vancouver area to provide learning opportunities that change lives. This vision is expressed through shared values, one of which is that VCC respects the environment and seeks to reduce its environmental impact.

To realize this vision, seven initiatives were established, one of which is to build and implement a college-wide environmental sustainability plan. This initiative has three objectives:

- Bring sustainability principles into the thinking, actions, culture and everyday operations of VCC.
- Demonstrate our respect for the environment as we educate students, staff and faculty about environmental stewardship.
- Seek innovations and improved practices that reduce our carbon footprint.


To demonstrate its commitment to achieving these objectives, VCC has resourced a new position at the College of Manager of Environment & Sustainability with a mandate to guide the College in integrating sustainability values and practices into VCC's strategic and operation planning processes, the management of its resources and operations, facilities planning and design, research activities and curriculum.

Through these actions, VCC will engage and empower our students, faculty, staff and the local community to help realize a sustainable future.

2011 Greenhouse Gas Emissions

In 2011, VCC emitted 3,080 tonnes of carbon dioxide equivalent (tCO2e)¹ from sources covered under the Carbon Neutral Government Regulation (see Figure One). Of these emissions, 95% come from heating, cooling and lighting our buildings and the remaining 5% come from the use of paper. VCC does not own any vehicles.

It was estimated that stationary fugitive emissions from cooling do

not comprise more than 0.01% of VCC's total emissions and to collect data for emissions from this source was not feasible. For this reason, emissions from this source have not been included in VCC's total greenhouse gas emissions profile.

Offsets Applied to Become Carbon Neutral in 2011

VCC has purchased 3,080 tonnes of carbon offsets from the Pacific Carbon Trust at a cost of \$77,000 (\$25 per tonne) to achieve carbon neutrality, as required by the Greenhouse Gas Reduction Targets Act. Emissions Reduction Activities

Actions Taken to Reduce Greenhouse Gas Emissions in 2011

VCC is working to understand and reduce our energy use at both our Broadway Campus and our Downtown Campus. The design for new chillers for Building A at the Broadway Campus has been completed and includes energy efficiency considerations. DDC (Direct Digital Controls) have been installed in selected floors at the Downtown Campus, enabling heating and cooling functions to be automatically controlled in order to achieve greater energy efficiency.

In 2011, reminder stickers were placed on all light switches to remind people to turn out the lights. In addition, stickers were placed on the paper towel dispensers encouraging people to use them wisely.

The Information Technology (IT) department has implemented server virtualization across both campuses. Computers and monitors are set with automatic power down functions. Using these power management programs, VCC has saved over 550,000 kilowatt hours (kWh) of electricity over the past two years. This is enough electricity to power 50 homes for a year.



VCC is also taking steps to reduce our use of paper. Most stand alone printers have been removed and replaced with multi-function units which have been set to print double-sided as the default. The Library has instituted a print-and-hold procedure for printing which has reduced the amount of unnecessary printing. Overall, VCC has reduced paper use by 35% over the past year.

Plans to Continue Reducing Greenhouse Gas Emissions 2012 - 2014

As part of the implementation of VCC's Strategic Plan, an Environment & Sustainability Plan for the college will be created in 2012 to both engage and educate the VCC family (staff, students

and employees) and to reduce the environmental footprint of the College while maximizing its social impact.

Over the next three years, VCC will continue to identify and take advantage of opportunities to cost-effectively reduce energy use. Working with both BC Hydro and Fortis BC, VCC will undertake energy audits to identify potential savings. New chillers are planned for the Broadway Campus and further installation of DDC at the Downtown Campus will help realize energy savings.


VCC will continue to reduce our use of paper by promoting paperless meetings, evaluating the expansion of the print-and-hold function and continuing to offer on-line training wherever possible. In 2012, VCC will also be launching a campus-wide green team program to engage the VCC family in cultivating a culture of conservation.

Actions to Reduce Provincial Emissions and Improve Sustainability

Over 10 years ago, the Student's Union at VCC stepped forward as leaders and began working on a campaign with other lower mainland colleges to obtain a U-Pass for students in the Lower Mainland, not just UBC and SFU students. In June 2010, the Provincial Government announced the U-Pass BC Program at the VCC Broadway Campus and in March 2011, after a student referendum, VCC began implementing the U-Pass system.



In 2011, VCC announced its participation in the Campus City Collaborative (C3), which brings together the City of Vancouver, the Vancouver Economic Commission (VEC) and six post-secondary institutions to work together towards the City's green economy targets. In 2012, VCC will participate in a Green Workforce Development Symposium to help determine the education and training that post-secondary institutions can develop to meet the needs of the green economy and a Greening Campuses Symposium to share ideas. VCC is also exploring synergies in the areas of food sciences and the local food movement that are compatible with our culinary programs.


