Issuance fee	\$500	 Due upon acceptance of bid. Charged for each title issued. Also applies to reinstatement of a drilling licence (see below).
Annual rent	\$3.50 per hectare	• Due upon acceptance of bid and then each year on the anniversary date.
Penalty for late rental payment within 60 days after anniversary	\$500	• Drilling licence expires after 60 days of non-payment.
Reinstatement fee	\$500	 The Minister has limited discretion to reinstate a drilling licence that expired due to non-payment of rent. The following criteria must be met, though meeting the criteria does not guarantee reinstatement: The non-payment was inadvertent or due to non-financial circumstances beyond the control of the former licensee; No portion of the expired drilling licence has been sold at a Crown disposition subsequent to the expiry of the drilling licence; and The former licensee submits a written application to the director for reinstatement, accompanied by the reinstatement fee of \$500 and the issuance fee of \$500 (totaling \$1,000 plus annual rent). The reinstatement fee, issuance fee and rent must be paid manually and cannot be paid electronically through ePayments.
Fee and annual rent for standard drilling licence continuation following initial term (section 3 (5) of the Petroleum and Natural Gas Drilling Licence and Lease Regulation)	Fee – \$500 Rent – \$7 per hectare	 An application for continuation must be made before the end of the term and must be accompanied by the continuation fee and rent. See <u>Guidance to the Administration of Petroleum and Natural Gas Drilling Licences</u> for more information.
Annual rent for other drilling licence continuations	\$3.50 per hectare	 Drilling over expiry is an exception. See <u>Guidance to the Administration of Petroleum and</u> <u>Natural Gas Drilling Licences</u> for more information.

Issuance fee	\$500	 Due upon acceptance of bid, or with lease selection application if converting to lease from a drilling licence. Charged for each title issued (including new leases issued from a split lease). Also applies to reinstatement of a lease (see below). All issuance fees must be paid electronically through ePayments except in the cases of split transfers (when a lease is divided into two or more leases), where the issuance fee and pro-rated rent must be paid manually. 		
Annual rent	\$7.50 per hectare	 Due upon acceptance of bid or with lease selection application and then each year on the anniversary date. Applies during the original term of the lease and during any continuations. 		
Penalty for late rental payment within 30 days after anniversary	1.5% of the rent	• Penalty increases after 30 days of non-payment.		
Penalty for late rental payment 31 to 60 days after anniversary	3% of the rent	• Lease expires after 60 days of non-payment.		
Reinstatement fee	\$500	 The Minister has limited discretion to reinstate a lease that expired due to non-payment of rent. The following criteria must be met, though meeting the criteria does not guarantee reinstatement: The non-payment was inadvertent or due to non-financial circumstances beyond the control of the former lessee; No portion of the expired lease has been sold at a Crown disposition subsequent to the expiry of the lease; and The former lessee submits a written application to the director for reinstatement, accompanied by the reinstatement fee of \$500 and the issuance fee of \$500 (totaling \$1,000 plus annual rent). The reinstatement fee, issuance fee and rent must be paid manually and cannot be paid electronically through ePayments.

Continuation with penalty – second and third years	\$25 per hectare	 May be used for 10-year leases not continued under other provisions. Not available for five-year leases. See the <u>Guide to Petroleum and Natural Gas Act Lease</u> <u>Continuations</u> for more information.

Certifying a copy of a record 16 pages or more	\$1 per page	 Charged in addition to the above fee for copying a record. Also applies to certifying an extract of 16 pages or more from a record. Must be paid manually.
