HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, represented by the Minister of Forests and Lands, Parliament Buildings, Victoria, British Columbia, V8V 1X4
(herein called the "Licensor")
OF THE FIRST PART
AND:

MACMILLAN BLOEDEL LIMITED, a body corporate, amalgamated under the laws of the province of British Columbia under certificate of incorporation No. 247324, and having its registered office at 2600-1075 West Georgia Street, Vancouver, British Columbia, V6E 3R9
(herein called the "Licensee")
OF THE SECOND PART

## WHEREAS:

A. Pursuant to the West Coast National Park Act, the Licensor and the Licensee have entered into an exchange agreement dated the 9th day of December, 1986, as amended, (the "Exchange Agreement"); and
B. Pursuant to the Exchange Agreement, the Licensor and the Licensee have agreed to amend TFL 44 to account for certain exchanges of land in TFL 44 which is within the boundaries of Pacific Rim National Park, for other land which is outside the boundaries of Pacific Rim National Park.

NOW THEREFORE THIS INDENTURE WITNESSES THAT pursuant to the West Coast National Park Act the parties hereto agree as follows.

A .CLE I

## DEFINITIONS

1.01 In this Agreement and the recitals:
(a) "Pacific Rim National Park" means the park created under the West Coast National Park Agreement, the National Parks Act (Canada) and the West Coast National Park Act; and
(b) "TFL 44" means tree farm license No. 44, made between the Licensor and the Licensee as of August 1, 1984.

ARTICLE II

## AMENDMENT OF SCHEDULE "A" OF TFL 44

2.01 The lands described in Schedule " $A$ " hereto are herewith withdrawn from the lands described in Schedule " $A$ " of TFL 44.
2.02 The lands described in Schedule "B" hereto are herewith incorporated into Schedule "A" of TFL 44 and the said lands so incorporated are and shall be henceforth part of and subject to TFL 44.
2.03 The timber licenses and partial timber licenses described in Schedule " $C$ " hereto are herewith withdrawn from the lands described in Schedule "A" of TFL 44.
2.04 Timber license TO885 is herewith incorporated into Schedule " $A$ " of TFL 44 and the said timber license so incorporated is and shall be henceforth part of and subject to TFL 44.

ARTICLE III

## AMENDMENT OF SCHEDULE "B" OF TFL 44

3.01 The lands described in Schedule "D" hereto are herewith withdrawn from the lands described in Schedule " $B$ " of TFL 44.
3.02 The lands described in Schedule "E" hereto are herewith incorporated into Schedule "B" of TFL 44 and the said lands so incorporated are and shall be henceforth part of and subject to TFL 44.

## INTERPRETATION

4.い Statutes

A reference to a statute in this Agreement means a statute of the Province of British Columbia unless otherwise stated and includes every amendment to it, every regulation made under it and any enactment passed in substitution therefor or in replacement thereof.

### 4.02 References

Unless the context otherwise requires, any reference to "this Agreement" means this instrument and all of the Schedules attached to it and any reference to any section or subsection by number is a reference to the appropriate section or subsection in this Agreement.

### 4.03 Headings

The headings or captions in this Agreement are inserted for convenience only and do not form a part of this Agreement and in no way define, limit, alter or enlarge the scope or meaning of any provision of this Agreement.
4.04 Schedules

Each Schedule attached to this Agreement is an integral part of this Agreement as if set out at length in the body of this Agreement.
4.05 Entire Agreement

This Agreement constitutes the entire agreement between the parties with respect to the subject matter of this Agreement and there are no representations or warranties, express or implied, statutory or otherwise and no agreements collateral to this Agreement other than as expressly set forth or referred to in this Agreement.

### 4.06 Further Acts and Assurances

Each of the parties will, upon the reasonable request of the other, make, do, execute or cause to be made, done or executed all further and other lawful acts, deeds, things, devices, documents, instruments and assurances whatever for the better or more perfect and absolute performance of the terms and conditions of this Agreement.
4.07 Severability

If any provision of this Agreement or the application thereof to any person or circumstance is invalid or unenforceable to any extent, the remainder of this Agreement and the application of such provision
to any other person or circumstance will not be affected or impaired thereby and will be valid and enforceable to the extent permitted by law.
4.08 No Waiver

No waiver by either party of a breach or default by the other party in the observance, performance or compliance of any of its obligations under this Agreement will be effective unless it is in writing and no such waiver will be deemed or construed to be a waiver of any other breach or default and failure or delay on the part of either party to complain of an act or failure of the other party or to declare such other party in default, irrespective of how long such failure or delay continues, will not constitute a waiver by such party of any of its rights against the other party.

This Agreement will be governed by and construed and interpreted in accordance with the laws of the Province of British Columbia.
