-Under 2 acres of production / year	 All farms must be registered annually with the Commission. A grower qualifies for a licence if they have registered their acreage, have a valid contract with a designated agency, and may be required to show compliance with a food safety plan.

- Under 300 hogs/year	 All producers must hold a Valid Producer Licence that is renewed annually. A producer must be marketing, or able to market 300 or more hogs per year.
