PROVIDER AND LOCATION REGISTRY

What is the Provider and Location Registry?

- Provider and Location Registry (PLR) is a central data repository for all provider and location related health information in BC.
- The PLR provides health information exchange between organizations.

How is access determined for the PLR?

• A signed agreement is used to indicate the rules for the sharing of provider information between users (sources and consumers).

What are the methods of access?

- Web services for real-time interactions (preferred)
 - Real-time distribution of provider adds and updates to authorized consumers via HL7-V3 messages.
- Manual database extracts
 - Frequency: daily, weekly, monthly?
 - o CSV, XML, or text files
- Web application
 - Stand alone user interface for adds and updates

What are the provider data attributes?

Mandatory core data:

- Provider Identifier (College or MSP practitioner identifier)
- Identifier Type (e.g. CPSID)
- Provider Name
- Demographics (Gender and Date of Birth)
- License Status
- Contact Address

Other attributes (optional):

- Telephone, Fax, Email
- Expertise
- Credentials
- Language
- Work Location
- License Conditions


Why would an EMR vendor integrate with the Provider and Location Registry?

Access to current name, location, contact information, or other details for physicians within the province are sometimes required by EMR vendors to populate lists of providers within the EMR for purposes such as referrals, letters, etc. Obtaining this information from the PLR using web services or regular database extracts provides a current, accurate source of data for this purpose that is designed to be "vendor friendly" and can replace other sources that may be less up-to-date or not designed for vendor use (E.g. the College of Physicians and Surgeons BC quarterly extract).
