Title: 2014 Carbon Neutral Action Report

Organization Name: School District 47 (Powell River)

Declaration Statement:

This Carbon Neutral Action Report for the period January 1st to December 31st, 2014 summarizes our emissions profile, the amount of offsets purchased to reach net zero emissions, the actions we have taken in 2014 to reduce our greenhouse gas emissions and plans to continue reducing emissions in 2015 and beyond.

Overview:

In 2014, School District 47 again made progress towards the overall reduction of greenhouse gases. The largest contribution to our reduction of greenhouse gases was receipt of LEED-Gold Certified status for our recently opened elementary School, Westview Elementary. The LEED certification will result in substantial cost and energy savings for years to come.

Furthermore, 2014 continued to see a reduction in the spaces the District has been leasing or renting. Renovations to the Oceanview Education Centre are nearing completion and will next year include a lighting upgrade. Once complete this facility will not only house the programs previously occupied in leased spaces within the community, but will allow us to house additional programs avoiding the need to lease program space in the future. This reduction on our building portfolio will continue to contribute to the annual decrease in greenhouse gas emissions.

Also, in 2014 was the substantial completion of a seismic renovation at Henderson Elementary School. This renovation included the replacement of all single paned windows throughout the building with new thermal double paned energy efficient windows, as well as a complete lighting upgrade, and in 2015 we will see the installation of an efficient high density boiler. These improvements will all contribute to reduced energy costs.

Also planned in 2015, are boiler upgrades in two elementary schools with window upgrades in one and further window upgrades in the other during 2016.

The Transportation Department again made progress in reducing greenhouse gases with the purchase of two new, fuel-efficient buses. These buses are both smaller and better match our carrying needs and will emit less than their larger counterparts.

On the school level, School District 47 continues to take pride in educating the next generation to protect our future by continuing with the funding of the Sustainable Schools Committee. Part of the mandate of the Board of Education is to increase awareness of and positive action in regard to reducing our carbon footprint in practical ways. Schools have further incentive to participate, as some of the financial savings have been returned to the schools to fund future projects, such as gardening programs and eco-friendly playground equipment. Other examples, on a smaller scale, are school recycling programs, which allow schools to use monies "earned" from returning beverage containers for classroom supplies. Our Sustainable Schools Committee continues to lead the work of educating and inspiring employees, providing inservice and working together with the Destination Conservation's school based teams. The Outdoor Learning Centre (OLC), completed in 2012, is also a large contributing factor to the education of students, in both its operation and programs offered. The OLC consists of several cabins and a main lodge, run largely on solar power and maintains other environmentally friendly operating practices. Each year, the OLC offers numerous educational programs to District students, instructing them in practices such as composting, and use of renewable energy sources in a hands-on way.

Evidence of our efforts can be found in the continued maintenance of lower greenhouse gas emissions from that of previous years. Our <u>Total GHG Emissions for 2014 was 1025</u>, with <u>859 in offsets</u> to make us Carbon Neutral.

We believe in the benefits of our continued efforts and look forward to seeing a further reduction in offsets over the next few years. Financially, we aim to put some of the savings directly back into our schools, funding materials that continue to educate and provide awareness of how to reduce our carbon footprint. Environmentally, we aim to make our small actions have a big impact, both in the present and in the future, as our students take what they've learned into their adult lives, into our community and far beyond. Socially, we aim to provide awareness and collaboration that our students would take what they've learned and share it with others. We are proud of our District, and continue to be amazed at the significant efforts from both staff and students in making positive changes that will better our world for years to come.


