II ISSUE:

Haida Gwaii Conservancies – Forest Act, section 60.5 Notice and 60.2 and 60.3 Deletion Orders

III BACKGROUND:

The Haida Gwaii Strategic Land Use Plan was signed by the Premier and the Council of the Haida Nation in December 2007. Included in this plan were a number of proposed protected areas, which have been under temporary protection under *Forest Act*, Part 13, as designated areas. As such, the Minister temporarily suspended forestry operations, and the Chief Forester temporarily reduced the allowable annual cut for these designated areas

On December 17, 2008, by Order-in-Council (OIC No. 977) several conservancies were established on Haida Gwaii with an effective date of December 30, 2008. On October 10, 2009, these conservancies were further established under the *Protected Areas of British Columbia Amendment Act, 2009*, (Bill 10 – 2009), and the Order-in-Council No: 977 was rescinded. The conservancies affect several forest tenures including, Tree Farm Licences (TFL) 25 and 39, Block 6, and several Timber Licences held by Western Forest Products Inc. (Western). Section 11(2.3) of the *Park Act* deleted the conservancies from the applicable management unit. As such, *Forest Act*, section 60.501 requires the minister to issue a notice, and a subsequent order under *Forest Act*, section 60.2 or 60.3.

IV DISCUSSION:

The following conservancies require *Forest Act*, 60.501 notices, and sections 60.2 and 60.3 deletion orders:

- Daawuuxusda
- Damaxyaa
- Kamdis
- Kunxalas
- Nang Xaldangaas
- K'uuna Gwaay
- Scaay Taaw Siiwaay K'adjuu
- Tlall
- Yaaguun Gandlaay
- Duu Guusd (addition)

It is recommended that the *Forest Act*, section 60 compensation process be initiated with Western prior to the Ministerial consideration of the request to subdivide TFL 39 and replacement of TFL 39 in January 2010, for the following reasons:

- The Haida Nation (HFN) support the subdivision of TFL 39 prior to its replacement, such that TFL 39, Block 6 would become a stand-alone TFL, thus available for purchase from Western by HFN;
- Initiation of the section 60 compensation process provides the statutory basis for expedited compensation settlement negotiations with Western regarding the impact of the conservancies.

The section 60 compensation process for the other impacted tenure holders will be initiated in the near future following additional review and analysis.

V CONCLUSION:

The establishment of the 10 conservancies on December 30, 2008, and the subsequent *Protected Areas of British Columbia Act* amendment has resulted in these areas being deleted under the *Park Act*, which under *Forest Act*, section 60.501 requires the Minister to:

- Serve notice of the order and,
- Issue a deletion order as per Forest Act, section 60.

I, Pat Bell, Minister of Forests and Range, under section 60.2 of the *Forest Act*, order that Crown land in a conservancy itemized in Column 1 of the Schedule below, effective on the date in Column 3 of the same item, is deleted from any part of a tree farm licence in Column 2 of the same item that, on that date, was within the boundaries of that conservancy.
