# IN THE MATTER OF TREE FARM LICENCE NUMBER 1 AMENDMENT NO. 27

#### BETWEEN

THE MINISTER OF LANDS, FORESTS, AND WATER RESOURCES, of the Province of British Columbia, who, with his successors in office is

hereinafter called "the Licensor" of the one part,

AND

COLUMBIA CELLULOSE COMPANY LIMITED, a corporation duly incorporated under the laws of the Province of British Columbia, and having its registered office in the City of Vancouver in the said Province,

hereinafter called "the Licensee" of the other part.

WHEREAS by an Indenture made in duplicate on the Fourth day of May in the year of Our Lord one thousand nine hundred and forty-eight between the parties hereto, the Licensor did grant unto the Licensee the management of certain Crown lands therein described subject to the terms and conditions set forth in the said Indenture:

AND WHEREAS the parties hereto have mutually agreed to amend the said Indenture as hereinafter set forth.

NOW THEREFORE THIS INDENTURE WITNESSETH THAT in consideration of the premises and the sum of One Dollar (\$1.00) of lawful money of Canada now paid by the Licensee to the Licensor, receipt whereof is hereby acknowledged, the parties hereto agree as follows:

(1) That Schedule "A" to the said Tree Farm Licence and any amendment, addition or other change made therein up to this date is herewith mutually cancelled by the parties hereto and the said Schedule "A", as attached to this Indenture and marked as Exhibit "A", shall be and is Schedule "A" to the said Tree Farm Licence, and the lands

listed in the said Exhibit "A" henceforth shall be and are subject to the terms and conditions of the said Tree Farm Licence as if the said lands had been originally included in the said Schedule "A".

- (2) That the indentures dated January 25th, 1951, January 26th, 1955, April 22nd, 1955, December 8th, 1955, February 10th, 1956, June 26th, 1956, August 9th, 1956, October 5th, 1956, December 20th, 1956, July 30th, 1957, December 5th, 1957, July 10th, 1959, August 21st, 1959, October 5th, 1959, January 27th, 1960 March 9th, 1960, August 1st, 1960, November 2nd, 1960, March 7th, 1962, June 7th, 1962, be and they are hereby cancelled.
- (3) Subject to the terms of this Indenture the parties hereto confirm the said Indenture dated the fourth day of May, 1948, in all other respects.
