INSTRUCTIONS

- Completion of this certificate entitles the wholesale dealer, identified below, to purchase natural gas without being charged carbon tax at the time of purchase.
- Do not complete this form if you are a retail dealer. A retail dealer may purchase natural gas from their supplier, without being charged carbon tax, if they provide a copy of their carbon tax registration certificate number to their supplier.
- This form must be completed each time you enter into a new sales contract/agreement.
- This certificate is only for natural gas purchased as a wholesale dealer. If you purchase natural gas for your own use and resale purposes, you:

- (i) must estimate the volume of natural gas you are purchasing for your own use and pay carbon tax on that estimated volume to your supplier, and
- (ii) record on this certificate only the estimated volume that you will be selling to another wholesale dealer or retail dealer.

If you use any of the natural gas that you purchased for resale, you must self-assess and remit carbon tax owing on that natural gas. Please see our **website** for the appropriate version of the *Carbon Tax Return – Self Assessors* form (FIN 112). You must file this return and remit carbon tax to the ministry by the 28th day of the month, following the month in which you used natural gas.

Alternatively, if you sell any of the natural gas that you purchased for your own use to another wholesale dealer or retail dealer, you may apply for a refund of taxes paid. Please see our **website** for the appropriate version of the *Application for Refund of Carbon Tax — Purchaser of Fuel* form (FIN 108).
