Amendment

WHEREAS:

- A. The Licensor and Licensee entered into a replacement agreement for Tree Farm Licence 37 dated March 1, 2010.
- B. In a letter dated January 3, 2013, the Licensee requested that the Minister delete 1.56 hectares of private land from the Schedule A Lands of TFL 37 for a BC Hydro electrical switching station.

- C. In accordance with the Allowable Annual Cut Administration Regulation, the proposed deletion would not trigger a change to the current Allowable Annual Cut of Tree Farm Licence 37.
- D. Tree Farm Licence, Instrument 59 dated April 10, 2013 did not include District Lot 348 in the description of land removed from Tree Farm Licence 37.

THEREFORE:

Instrument 59 dated April 10, 2013 is cancelled and replaced with this instrument.

In accordance with Section 39.1 of the *Forest Act*, the Minister, with the consent of the Licensee, hereby changes the boundary and area of Tree Farm Licence 37 by removing approximately 1.56 ha of private land (parts of District Lot 134 (PID 008-227-837) and District Lot 348 (PID 008-227-322)) from Schedule A Lands of Tree Farm Licence 37 as identified by the bold black line on the attached map "Proposed Kokish Substation Location, Beaver Cover, BC – NOV 2012".

For the purposes of Section 8(2) of the *Allowable Annual Cut Administration Regulation* the AAC for the area removed from Tree Farm Licence 37 is 0m^3 /year.
