# **Referral Summary**

# Referral of Draft Management Plan 4, Timber Supply Analysis Information Package and Timber Supply Analysis Report for TFL 52

Given below is a summary of the referrals undertaken for the Draft Management Plan 4 and Timber Supply Analysis Report as part of the consultation process. Our records indicate that the Red Bluff (Lhtako), Xat'sull (Soda Creek), Nazko, Lheidli T'enneh and Williams Lake Bands have traditional territories covering all or parts of TFL5 and 52. The Williams Lake Band has advised us that they do not have any overlapping interest area, however we have continued to provide referral material.

Letters were also sent to all licenced resource users (guides trappers, ranchers) within the bounds of the TFL advising that the Draft MP 4 was available, and invited comments or suggestions. One response from the Cariboo Ski Touring Club was received indicating that their interests were satisfactorily considered.

In all letter and e-mail correspondence, we invited comments and/or offered to meet and discuss, and/or offered to provide more information.

# Nov 29 – Dec 1, 2006:

A copy of the Draft MP4 with an explanatory covering letter was delivered by hand to each of the Band offices. The covering letter requested that comments be forwarded to me by January 29, 2007. I spoke with Chief Frederick at the Lheidli T'enneh office, Blair Powell at the Nazko office and Chris Wycotte at the Williams Lake Band office as I delivered the document. A copy of the plan was left with the receptionists at the Xat'sull and Red Bluff offices.

## Dec, 18-19 2006

An e-mail note was sent to the Leidli T'enneh, Xat'sull and Williams Lake Band offices asking whether more information or clarification was needed, and stating that I could arrange a meeting if desired. On December 19<sup>th</sup>, I visited the Red Bluff Band office. Chief Lebrun was not available, so I followed up with an e-mail note similar to that sent to other Bands the previous day. I met briefly with Blair Powell at the Nazko Band office, and also followed up with an e-mail note. At that time Mr. Powell had not reviewed Draft MP 4.

#### Jan 12, 2007

An e-mail note was sent to each of the Band offices, again asking if more information or clarification was needed and stating my willingness to meet.

## Jan 22, 2007

Received an e-mail note from Joanne Ramsay, RPF, stating that the Williams Lake Band did not have an interest on either TFL 5 or 52 and therefore would not be commenting.

## Jan 23, 2007

Wayne Boudreau, RPF, on behalf of the Cariboo Ski Touring Club, stopped in the WFM office to review maps of the Two Sisters, Mt Murray and Mt. Tinsdale areas. No concerns were expressed, gathering information only.

## Jan 29, 2007

An e-mail note similar to that of Jan 12<sup>th</sup> was sent, asking that any comments that might be forthcoming be sent to me by February 5<sup>th</sup>.

#### March 6, 2007

Phoned Nazko, Red Bluff and Williams Lake Band leaving messages requesting a meeting with either the Chief or Resource Manager. No responses received.

## March 11, 2007

Phoned Lheidli T'enneh office and requested a meeting on March 12<sup>th</sup>, if possible.

## March 12, 2007

Delivered a copy of the Timber Supply Review Information Package to the Lheidli T'enneh office. No one was available to meet with or to discuss with.

## March 13, 2007

Met with Ken Michel at the Xats'ull office and reviewed the Info Package (and other material) with him. No specific concerns were expressed then, and no subsequent comments were received.

Dropped off a copy of the Info Package at the Williams Lake Band office. Chris Wycotte was not in.

## March 14, 2007

Met with Alecia Hjorth at the Nazko Band office, and briefly outlined the contents and purpose of the Info Package (and other material).

Dropped off a copy of the Info Package with the receptionist at the Lhtako Band office. No one was in to discuss it with.

## April 2, 2007

E-mail notes were sent to Ken Michel (Xats'ull), Dominic Frederick (Lheidli T'enneh) as a follow-up to material provided on March 12-14.

A follow-up letter was delivered to the Lhtako and Nazko offices and left with receptionists, as no one else was available.

# April 17, 2007

E-mail notes were sent to Lheidli T'enneh, Xats'ull, Lhtako, Nazko, and Williams Lake Bands as a follow-up to information provided in March.

# Oct 5-12, 2007

A copy of the Timber Supply Analysis Report was mailed or delivered to Lheidli T'enneh, Xats'ull, Williams Lake, Nazko and Lhtako First Nations, along with a covering letter stating that this was information only and that MoFR would be following up prior to the AAC determination.

## Oct 10-21

Newspaper advertisement placed in the Quesnel-Cariboo Observer advising that the analysis report is available for review if anyone is interested in looking at it.
