Ministry of Transportation and Infrastructure Major Capital Project Plan: Highway 91/17 and Deltaport Way Upgrade Project Budget Transparency and Accountability Act Disclosure

Project Scope

The Highway 91/17 and Deltaport Way Upgrade Project is a combination of improvements to the existing Highway 91, Highway 17, Highway 91 Connector and Deltaport Way to improve travel safety and efficiency. These upgrades will improve local and commercial travel in the area and reduce conflicts between commercial vehicles and other traffic. They also complement the recently completed 72nd Avenue Interchange Project and the Alex Fraser Bridge improvements.

The project scope includes construction and expansion of the following highway components:

- upgrades to the Highway 91/Nordel Way Interchange;
- a new Highway 91 Connector/Nordel Way Interchange;
- a new Highway 17/Highway 91 Connector Interchange;
- a new Highway 17/River Road Interchange;
- upgrades to the Highway 17 and 80th Street intersection; and
- upgrades to the 27B Avenue and Deltaport Way intersection.

Project Objectives and Benefits

The project objectives and benefits are:

- improved safety, mobility and reliability;
- reduced congestion and improved access to industrial lands in the municipality of Delta;
- improved access to the Nordel Commercial Vehicle and Safety Enforcement Inspection Facility, enabling the facility to maintain full-time operations and vehicle inspections; and
- improved access to the Canadian Border Services Agency container examination facility.

Project Cost

The total estimated capital project cost is \$260.2 million. The project will be funded in partnership by the Province (\$87.5 million), the Vancouver Fraser Port Authority (\$87.5 million), Infrastructure Canada (\$81.7 million through the National Infrastructure component of the New Building Canada Fund) and Tsawwassen First Nation (\$3.5 million). Following the procurement process for the design-build agreement, the project budget was increased from \$245.2 million to \$260.2 million to reflect a variety of factors, including current market conditions.

The project cost includes procurement, design, engineering construction, land acquisition, First Nation consultation, archaeology and project management.

Risks

The primary project risks are:

- changes related to geotechnical and environmental issues;
- soil contamination due to previous industrial use;
- construction schedule delay; and
- traffic management during construction.

The project scope, schedule and budget have been developed with consideration for the above risks and the probability of occurrence.
