SPECIES LICENCE CANCELLATION INSTRUCTIONS

Immediately upon killing an animal of the species stated on this licence and before handling the animal, this species licence must be cancelled by cutting out and completely removing the applicable notches on the edge of the licence to denote:

1. Day of kill 2. Region of kill 3. Month of kill

4. Antlered or antlerless (applicable to Deer, Elk or Moose only) Licence alteration and/or improper cancellation can lead to prosecution. Pre-cancellation, partial cancellation and over cancellation are considered to be improper cancellation and automatically render a licence null and void.

Step 9 – Print Expiry Year, Name and FWID on Species Licence

- Write the year of Expiry, for the hunting licence year that was selected during the purchase process (licence year also shown on the E-Licensing printed receipt e.g. Step 8).
- Print clearly the FWID and First Name and Last Name of the hunter
- If the customer bought on behalf of another hunter, make sure you are writing the correct name on the licence. Use the printed receipt to match the licence number on the licence tag to make sure you are printing the correct name and FWID on the correct species licence.

NOTE:The species licences expire on March 31 of the licence year they are purchased for. Example: If the licence year is 2020/**21** then the expiry date is March 31, 20<u>**21**</u>
