

THIS AGREEMENT dated Nov. 16, 2016.

### BETWEEN:

HER MAJESTY THE QUEEN IN RIGHT OF THE PROVINCE OF BRITISH COLUMBIA, as represented by the Minister of Aboriginal Relations and Reconciliation ("British Columbia")

OF THE FIRST PART

AND

**HUU-AY-AHT FIRST NATIONS**, as represented by Huu-ay-aht First Nations Government ("Huu-ay-aht First Nations")

OF THE SECOND PART

(each, a "Party", and together, the "Parties")

#### WHEREAS:

- A. The Parties entered into the Real Property Tax Co-ordination Agreement on April 1, 2011; and
- B. Section 12.1 of the Real Property Tax Co-ordination Agreement provides that any amendment to that agreement must be in writing and executed by both Parties;

**NOW THEREFORE** in consideration of the premises and the covenants and agreements set out below, the Parties agree as follows:

### 1.0 DEFINITIONS

- 1.1 In this Agreement:
  - "Agreement" means this Real Property Tax Co-ordination Agreement Amending Agreement;
  - "Agreement Date" means the date first above written; and
  - "Real Property Tax Co-ordination Agreement" means the agreement of that name between Her Majesty the Queen in right of the Province of British Columbia and the Huu-ay-aht First Nations, dated for reference April 1, 2011.

# 2.0 AMENDMENTS TO REAL PROPERTY TAX CO-ORDINATION AGREEMENT

2.1 The Parties agree that subparagraph 8.1(b)(iii) of the Real Property Tax Coordination Agreement is amended by inserting after the word "class" the following:

"or, if the rate established by the District of Ucluelet for that class is zero, the rate set for that class for tax under section 20 of the *Taxation (Rural Area) Act* for the region of the province within which Maa-nulth First Nation Lands of the Huu-ay-aht First Nations are located"

## 3.0 COUNTERPARTS

3.1 This Agreement may be signed in one or more counterparts. A signed counterpart may be delivered by a Party to the other Party by facsimile transmission and a facsimile so transmitted will constitute an original document. Signed counterparts held by a Party, taken together, will constitute one and the same instrument.
