


Buy a Licence on Behalf of a Youth

<p>Who can buy on behalf of a youth?</p>	<p>Parents or legal guardians who are 18 or older.</p> <p>Licensed Guide Outfitters who hold a valid guide outfitter licence as long as they provide the required forms (written undertaking and/or licence application form) signed by the youth's parent or legal guardian.</p> <p>Permit To Accompany holders can buy species licences on behalf of a youth named on their valid permit. They cannot buy a resident hunting licence or youth licence.</p>
<p>What licences can I buy for a youth?</p>	<p>A licensed guide outfitter or a parent or legal guardian can buy for a youth:</p> <ul style="list-style-type: none"> • A resident hunting licence • A non-resident or non-resident alien hunting licence (restricted or unrestricted) • Species licence(s) <p>Only a parent or legal guardian can buy for a youth:</p> <ul style="list-style-type: none"> • A youth licence

Before you start

Before you buy on behalf of a youth, make sure you have:


- A verified, active **Fish and Wildlife ID**
- Credit card for payment

Make sure the youth has:

- A verified, active **Fish and Wildlife ID**
- An active **residency credential**
- A **hunting credential** (depending on the licence type you want to buy for them)

From your (adult buying on behalf of a youth) Fish and Wildlife profile:

- Click on **Buy Licences** under the **Licences** lefthand menu item



Search for the youth's profile

Click **Buy Licences on Behalf of a Youth** - a pop-up box will appear:

- Enter the youth's FWID, last name and first initial
- Click **Search**

NOTE: If you do not find the youth you are buying licences for, you will need to contact **FrontCounter BC** for assistance.

ADD ANOTHER LICENCE

All hunters are now required to carry all of their cancelled and uncanceled species licences for the same licence year while hunting. All youth must know or be able to produce their FWD number. Youth 16 years of age or older must also carry photo ID while hunting. Youth under 16 years of age are not required to carry photo ID.

If the youth plans to hunt in the next several days, consider buying the species licences at any participating vendor location please call ahead prior to traveling to the vendor location.

Species licences bought online will be mailed to you and are subject to Canada Post delivery times. You may qualify for a free replacement if you report to HuntCounter BC contact centre at 1-877-855-3222 within 15 to 30 business days from the date of purchase that you have not received your licence. You will be prompted to confirm your mailing details before you complete your purchase.

Buying a species licences for a youth

NOTE: You can't buy a species licence for a youth if they do not have a hunting licence. Make sure you add their hunting licence to the shopping cart before you try to buy a species licence.

- Choose the species licence you want to buy from the **Licence Type** dropdown
- Choose the number of licences (applies only to species with a bag limit over 1)
- Repeat the two previous steps until all of the licences have been added

A resident hunting licence is available to anyone at least 10 years of age and under 18, who is a verified user with an active FVID and active resident and hunting credentials. A parent/guardian must buy the licence on behalf of the youth and must complete the Written Undertaking and attestation below before buying the licence. You can buy species licences on behalf of the youth once you have added the youth's Resident Hunting Licence to your shopping cart.

There is no paper version of this licence. All youth hunters must know or be able to produce their FVID while hunting. Youths 16 and over must carry photo ID.

Complete the written undertaking

Before buying a youth licence or a hunting licence on behalf of a youth, a written undertaking must be provided. If you are a licensed guide outfitter (purchasing as agent) buying a hunting licence on behalf of a youth, a hunting licence application form signed by the parent or guardian will also be required.

NOTE: If you are buying **only** species licences on behalf of a youth, you do not have to complete a written undertaking.

If you are the parent/guardian of the youth:

- Click **Sign the Written Undertaking**
- Click the box to confirm that you intended to provide an electronic signature

If you are a licensed Guide Outfitter (Agent):

- Upload the **Written Undertaking** document that has been signed by the parent or legal guardian
- Upload the signed **Hunting Licence Application** form that has been signed by the parent or legal guardian
- Click the box to attest that you have been authorized by the applicant to submit a hunting licence application

Then:

- Answer the **Survey Question** (dropdown)
- If you added a hunting licence, you can choose to add species licence(s) click **Add Another Licence** (and follow instructions on next page); **or**,
- If you don't want to purchase any additional licences, click **Add to Shopping Cart**, then click **Proceed to Checkout** and follow the Pay and finish instructions on the next page


If you purchased species licences, confirm your shipping address

NOTE: The licence will also appear in the youth's profile, however, the youth will not be able to view the receipt.

Youth/Hunting licences are electronic and **do not need to be printed**; however, hunters must carry all of their species licences for the current licence year with them while hunting. Hunters aged 16 and older must also carry photo ID to present to an officer on request.
