# INFORMATION SHEET – OUTSTANDING WARRANTS

Ministry of Social Development and Poverty Reduction

- Individuals who have an outstanding arrest warrant for an indictable offence in Canada, or an arrest warrant under the *Immigration and Refugee Protection Act* (Canada) are not eligible for income assistance, hardship assistance, disability assistance, or most supplements.
  - o Exceptions will be made for those under the age of 18, people who are pregnant or who are in the end stage of a terminal illness.
  - o If an adult in a family unit has a warrant, the remaining family members may still be eligible for assistance.
- Individuals are required to disclose whether they have an outstanding warrant at application, on their monthly reporting requirements, and during eligibility audits.
- Individuals are required to provide consent for the ministry to confirm with the Ministry of Public Safety and Solicitor General if they have an outstanding warrant.
- Failing to disclose the existence of an outstanding warrant may result in an overpayment.
- Individuals wishing to resolve an outstanding warrant can request a repayable supplement to
  cover the least expensive appropriate one-way transportation for themselves (and their
  spouse and/or dependent children, if applicable) to return to the jurisdiction that issued the
  warrant.
  - o In some circumstances, a warrant may be resolved at a local police station without returning to the jurisdiction which issued it.
- While dealing with an outstanding warrant, individuals and families may be eligible for repayable assistance. This assistance is repayable and, in most cases, will only be provided for three months.

**Resolving an outstanding warrant:** Providing one of the following documents may demonstrate that a warrant is resolved: promise to appear, recognizance, undertaking, appearance notice, or request for waiver.
