- A. Pursuant to the provisions of the *Forest Act*, the Licensor and Licensee entered into a replacement agreement for Tree Farm Licence 48, dated December 1, 2008;
- B. The Licensee and Licensor have agreed to amend Tree Farm Licence 48.

THEREFORE:

The parties agree to delete Paragraph 2.01(e) of Tree Farm Licence 48 and replace it with the following:

- (e) the total timber volume harvested on the Tree Farm Licence area under
 - i. Master Licence to Cut issued by the Oil and Gas Commission, and
 - *ii*. Occupant Licence to Cut issued to holders of mineral tenures is deducted from
 - the volume of timber available to the Timber Sales Manager under
 (b) to (d), or if there is insufficient volume available under (b) to
 (d)
 - ii. the volume of timber available to the Timber Sales Manager under (a).

The parties agree to re-number Paragraph 3.4 of the "Interpretation of Schedule "B", TFL 48" to 3.3.

The parties agree to delete the description of "Block 3 addition area" in Schedule "B" of Tree Farm Licence 48 and replace it with the following:

BLOCK 3 (Addition Area)

1753.1 hectares, more or less, identified as the "TFL 48 addition area" as outlined in bold black on the map attached to this schedule dated June 9, 2003 and attached to Instrument #5 dated July 27, 2004.
